1 Purpose

- 1.1 The purpose of this report is to provide details of the proposals, to report the responses received during the consultation period and to seek approval to proceed with the recommendations as set out in Section 11 of this report.
- 1.2 During 30 September 2020 and 21 October 2020, the Council undertook a statutory consultation on proposals to introduce waiting and loading restrictions and parking place changes at 22 locations all within N15, as detailed in Table 1 below.

2 Background

- 2.1 The Council receives many requests to introduce new, or to amend existing parking restrictions to address concerns relating to parking pressures including inconsiderate and obstructive parking. These concerns may originate from a variety of sources such as residents, businesses, elected representatives, community groups and other public service providers, or the emergency services.
- 2.2 Inconsiderate and obstructive parking can be a cause of concern to road users of all types. As well as affecting other motorists, it can result in reduced sight lines contributing to an increased risk of collisions impacting on the road safety of pedestrians and cyclists. Poorly parked vehicles may impede access and contribute to road congestion. This can impact on the movement of emergency services, public transport, waste collection and larger delivery vehicles.

3 Proposals

3.1 Table 1 below lists locations where concerns or requests have been raised with regards to parking restrictions or parking places. Each location has been investigated and the table outlines the proposals we are seeking to approve. The designs for each location are contained within **Appendix 1**.

4 Statutory Notification

- 4.1 Statutory notification was undertaken on the proposals detailed in Table 1 of section 3.1, on 30 September 2020 for a period of 21 days. This adheres to the legal requirements set out in section 7 of this report.
- 4.2 As part of the statutory process a Notice of Proposal was published in the London Gazette, Enfield and Haringey Independent. In addition, the notice was erected on site in the affected streets. The statutory notification consisted of 22 locations.
- 4.3 *See Appendix 2 for a copy of the Notice of Proposal erected on site.

5 Statutory Notification Feedback

- 5.1 No representations have been received from the statutory bodies stated.
- 5.2 The Council received no objections and no representations in favour to the proposals listed in Table 1 of this report.

6 Chief Financial Officer Comments

6.1 The capital costs of waiting, loading, and parking place measures outlined in this report can be met from the Parking Plan funding which forms part of the 2020-2021 budget.

7 Legal Requirements

- 7.1 Before reaching a decision to make the necessary Traffic Management Order to implement or amend a CPZ scheme, the Council must follow the statutory consultation procedures pursuant to the Road Traffic Regulation Act 1984 ("RTRA") (as amended) and the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended). In carrying out the notification the council must comply with the principles ("Sedley Principles") set out also by the courts which are: that notification must be at a time when proposals are still at a formative stage; that the proposer must give sufficient reasons for any proposal to permit of intelligent consideration and response; that adequate time must be given for consideration and response; and that the product of notification must be conscientiously taken into account in finalising any statutory proposals. All objections received must be properly considered in the light of administrative law principles, Human Rights law and the relevant statutory powers.
- 7.2 The Council's powers to make Traffic Management Orders arise mainly under sections 6, 9, 45, 46, 122 and 124 and schedules 1 paragraph 8 and 9 of the RTRA.

- 7.3 By virtue of section 122, the council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and the provision of suitable and adequate parking facilities on and off the highway. These powers must be exercised so far as practicable having regard to the following matters: -
 - (a) The desirability of securing and maintaining reasonable access to premises.
 - (b) The effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve amenity.
 - (c) The national air quality strategy.
 - (d) Facilitating the passage of public service vehicles and securing the safety and convenience of their passengers.

Any other matters appearing to the council to be relevant.

8 Comment of the Head of Legal Services

8.1 Other than the requirements set out in section 7 above there are no other legal implications arising out of this report.

9 Equal Opportunities

- 9.1 During the statutory notification period any interested parties are permitted to make representations regardless of the following protected characteristics: age, disability, gender reassignment or pregnancy and maturity.
- 9.2 The Council must, when carrying out the Council's functions (which includes making decisions), have due regard to the needs set out in section 149 of the Equality Act 2010 (the Public Sector Equality Duty ('PSED')). This duty includes having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic (including people with a disability) and persons who do not share it. The Council must consider the duty, which is personal to decision makers.

10 Summary

- **10.1** The Council received no representations to the proposals listed in Table 1. These changes are proposed to provide further loading facilities to neighbouring businesses and more parking opportunities for residents and visitors by converting an area of waiting restriction into permit parking and converting existing permit holder parking bays and pay by phone bays into shared use.
- 10.2 As no representations were received, Officers recommended to proceed with proposals listed in Table 1 of this report.

11 Recommendations

- 11.1 It is recommended that the Head of Service for Highways and Parking approves the following:
- 11.2 Implement proposals 1-22 as consulted upon and detailed under Table 1 within section 3.

PROPOSED AMENDMENTS TO SOUTH TOTTENHAM CONTROLLED PARKING ZONE -T02 THE HARINGEY (SOUTH TOTTENHAM CPZs) (DESIGNATIONS) (AMENDMENT NO.*) ORDER 202*, THE HARINGEY (SOUTH TOTTENHAM CPZs) (SECTION 6) (AMENDMENT NO.*) ORDER 202*

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey proposes to make the above mentioned Orders under the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Orders would be to:-
 - (a) amend parking controls in the following roads to implement the following types of parking places operating at zone hours:
 - i. extending the length of permit holder only bays
 - ii. converting permit holder only bays to shared use bays with either a maximum stay of 1 hour or 1.5 hours with no return for 1 hour
 - iii. converting pay by phone bays to shared use bays with either a maximum stay of 1 hour or 1.5 hours with no return for 1 hour
 - iv. converting permit holder bays into 3 Ambulance bays operating at any time
 - converting the times of an existing loading bay maximum stay 20 minutes with no return for 1 hour.

Fairview Road, Ferndale Road, Lealand Road, Gladesmore Road, Crowland Road, Elm Park Avenue, Clifton Gardens, Wellington Avenue, Norfolk Avenue, Cadoxton Avenue, Barry Avenue, Rostrevor Avenue, Leadale Road, Lockmead Road, Craven Park Road, Riverside Road, Grovelands Road, Wargrave Avenue, Castlewood Road

- 3. Copies of the proposed Orders, and of the Council's statement of reasons for making the Orders, and plans showing the locations and effects of the Orders may be inspected during normal office working hours until the end of a period of 6 weeks from the date on which the Orders are made or the Council decides not to make the Orders, at the reception desk, Alexandra House, 10 Station Road, Wood Green, N22 7TR, by appointment only, or can be viewed online at www.haringev.gov.uk/traffic_orders.
- 4.
