Your Personal Data

Personal data in the form of registration number, photographs of you and your vehicle may be obtained to ensure compliance with contractual obligations when on this Private land. The data may be retained and shared with third parties for enforcement and car park management purposes.

Where a parking charge becomes due or remains unpaid an application may be made to the DVLA for the keeper's details to allow notices to be sent through the post. You have the right to request the following relating to information we may hold about you: Inform you how and why it is processed; give you Access to it; Rectify inaccuracies; Delete it; Restrict our use; Transfer copies to third parties and Object to our processing. Under data protection law we must; verify your identity before providing information and provide you with an explanation if we do not agree with your request.
