Following three competitive quotes to undertake the work and in accordance with CSO 8.03, to award the contract to Local Data Company (LDC) for the installation of 5 x footfall device sensors at locations selected by LBH (Tottenham and Crouch End); access to footfall data and location insights; and quarterly reporting to summarise footfall data for each sensor including daily, weekly, monthly, and annual footfall averages

4. Reasons for decision

4.1.LDC will deliver the footfall data and additional location insights in the following formats: via an online portal, Local Data Online, which is accessible for up to 4 authorised council users, as well as bespoke quarterly reports which can be shared with wider teams, investors, and hosts. Both weekly and monthly footfall reports can be exported automatically via Local Data Online.



- 4.2. The total cost for the provision of these services for a 12-month period is £12,550 and is funded through the ERDF supported Reopening the High Streets Safely Fund.
- 4.3. In accordance with CSO 8.03 as the budget for this procurement was over £10k and under £160k, competitive quotes were sourced from three potential providers. They were:
 - Local Data Company
 - Proximity Futures
 - Springboard Research
- 4.4. Local Data Company scored the highest overall with a score of 82%. The award is based on the most economically advantageous tender, i.e., a mixture of price and quality.

If the council were to adopt a do nothing approach it would have a detrimental impact on the council's ability to deliver evidence-based interventions for the borough's high streets and town centres and impact on the council's ability to ensure the safety of the public as lockdown restrictions are relaxed.

- 6.1 Town centres in Haringey (incl. Tottenham and Crouch End) have been profoundly impacted by the Covid-19 crisis. Town centres across the borough have seen a significant reduction of footfall which has an impact on their vitality and the well-being of businesses.
- 6.2 As part of the council's approach to safe opening and safe shopping on its high streets and managing the impact of Covid-19 in the medium and longer term, the requirement for footfall counting and data analysis has become more essential than ever before.
- 6.3 Footfall counting and data analysis has a primary a role in assessing the economic wellbeing and vitality of our town centres and provide important information on activity patterns. This information will play a key role in local decision making and evidence-based interventions and help plan for town centre recovery
