Following a competitive RFQ tender process and in accordance with Contract Standing Order (CSO) 8.03 award the contract to **Springboard Research Limited** for the installation and maintenance of 17 x footfall camera devices and provide data and options for relevant analysis on footfall for several town centres in Haringey for the amount of £74,945 (Excl VAT).

#### 4. Reasons for decision

Town centres in Haringey have been profoundly impacted by the Covid-19 crisis. As part of the council's Good Economy Recovery Plan and High Streets Recovery Action Plan response to supporting businesses through the pandemic and managing the impact of Covid-19 in the short to medium-term term, the requirement for footfall



counting and data analysis has become more essential. Footfall counting and data analysis has a primary a role in assessing the economic wellbeing our town centres and will play a key role in local decision making and help plan for town centre recovery.

- There is a necessity for the council to deliver evidence-based interventions and
  policies for the borough's high streets and town centres and impact on the council's
  ability to ensure their sustainability and monitor each town centre's performance
  through the recovery.
- The total cost for the provision of these services for a three-year period is £74,945 plus VAT and is funded through the ERDF Welcome Back Fund (£39,000 to be spent by end of March 2022 and Future High Streets Fund (£35,945 to be paid in full in 2021/22). The breakdown of funding is as follows:

- In accordance with CSO 8.03 as the budget for this procurement was over £10k and under £160k, competitive quotes were sourced from a minimum of three potential providers. Three consultants were invited to submit a Request for Quotation (RFQ) through the HPCS portal. A further three were invited by email and requested to register on the HPCS portal. One consultant - Springboard Research Limited responded to the RFQ.
- Despite there only being one response submitted, **Springboard Research Limited** achieved the necessary level of response to the RFQ to be selected as the successful bidder. Springboard Research Limited achieve the following quality and price evaluation score:

### 6.0 Background



- Town centres have been profoundly impacted by the Covid-19 crisis. They have mostly seen significant changes of footfall which has an impact on their vitality and the well-being of businesses. Since the easing of restrictions, town centres have experienced very different patterns of footfall due to a sharp increase in online retailing, more people working from home and staying local when they do so and the impact of furlough and job losses impacting spending patterns. The Council is therefore looking at the vitality of its main high streets and managing the impact of Covid-19 in the medium and longer term and wishing to analyse the patterns arising.
- Footfall counting and data analysis have key roles in assessing the economic wellbeing and vitality of our town centres and providing important information on activity patterns. This information will play a key role in local decision making and evidence-based interventions and help plan for town centre recovery. It will also be shared with the relevant town centre business networks as part of their planning for the future.
