Haringey Council have reviewed and reviewed their Home-School transport policy to ensure that it follows national guidance and continues to meet the council's objectives regarding sustainable transport. - d) introduction of behavioural standards for children and young people using transport commissioned by the Local Authority.
- e) detailed explanation of the transport decision making process.
- f) standardisation of disputes and appeals process in accordance with statutory guidance
- g) clarification of 'personal travel budgets' and how they are calculated.
- h) comprehensive 'Application' procedure and guidance.
- i) clarity around breakfast/ after school clubs and times when Haringey will provide transport.
- j) COVID-19 information in relation to home-school transport.
