I am objecting to the <u>New Extended Drinks & Entertainment Licence</u> issued to 'Funky Brownz' for the above premises based on the following licensing objectives:

1. The Prevention of Crime and Disorder:

For years, residents in Ribblesdale Road and, to a lesser extent Gisburn Road, have had to put up sleepless nights from the sound of noisy violence and drunken behaviour when the above establishment was managed/owned previously by the Wishing Well Pub.

2. Public Safety:

Drunks hanging around outside the above establishment can be very intimidating to local residents and people just passing through Ribblesdale Road. If the establishment acquires the reputation for violence associated with binge drinking on the premises it will lower the tone of the whole neighbourhood near the establishment.

3. Prevention of Public Nuisance:

Sleep disruption as noise levels travels far; along with the lack of parking spaces for local residents and visitors may lead to, at best, unpleasant altercations between local residents and clientèle of the Funky Brownz establishment above, and at worst actual violence, which could be prevented by rejecting the application for this licence.

4. The Prevention of Harm to Children:

The likelihood that under 18 teenagers will gain entrance to the above establishment and be exposed

Crime & disorder - I'm pretty sure, judging by the name, that this will entice gun crime, drugs and drug dealing, drunks looking for the last drink and violence, damage to cars and property, antisocial toilet behaviour, litter, drink driving, fights and police activity.

Public safety - intimidation of people coming home from work via Hornsey Rail Station, drunks in the street, gangs loitering outside, fire safety.

Public nuisance - loud DJ music, noisy revellers smoking outside the premises, lack of parking spaces, increased traffic (taxis, cars, coaches, deliveries).

Dear Sir/s and/or Madam/s:

I am writing in response to the New Extended Drinks & Entertainment License for "Funky Brownz" at No. 5 Tottenham Lane, Hornsey, London N8 9DL. I am writing about this licensing application with regard to the prevention of crime, disorder, public nuisance and ensuring public safety in my area. Firstly I was surprised and dismayed not to receive any notice about this change of establishment function until really recently (and I found out through neighbours and not through any official channels). Secondly, while there have been some noise and disturbance issues with the Wishing Well pub, formerly on the same premises, they have not been a significant problem for me. I would not be averse to another pub in that location with reasonable opening hours.

However, as a resident of Ribblesdale Road, across the street from this establishment, I am very concerned about the proposal to extend the hours to have new closing hours from 1:30-4:30 am, especially on weeknights. I am also dismayed by the prospect of having an adult nightclub rather than a pub down the street. This is a very quiet, residential neighbourhood, with families and young children who go to bed quite early. It seems to me to be a very strange place to have a nightclub in the first place, and I would not at all like to have a nightclub a few doors down from my home. I have no objection to nightclubs or, indeed with adult forms of entertainment, *if they are not located in a residential area*.

My husband and I are expecting our first child in December, and we have been very happy with the atmosphere of our quiet, residential street since moving here in February of 2008. I would be very dismayed to have that atmosphere disturbed and our neighbourhood disrupted by a nightclub that is open so late every single night. Even if they have security, I feel that not only will noise be a problem, but I am also afraid that drunken behaviour and crime will rise in this area as a result of this nightclub. Frankly, the Wishing Well already brought some undesirable behaviour into our street (people vomiting and urinating in our front yards, people getting into fights), but at least it was not open as late as this nightclub will be and did not have as many clientele as are likely to be brought into a nightclub.

In short, I would very much like this licensing request to be turned down and I am very keen to attend any public meetings/hearings on this matter so that I can make my concerns known to the committee in person. I look forward to hearing from you soon.

- **(b)** The SIA registered door supervisors power & interest will cease the moment customers vacate the premises. In the past it has been my experience that the customers congregate outside & that's when the trouble starts. This is especially true when it's an organized function such as a stag night or birthday nights. I have seen 30-50 people fighting, screaming & shouting up to 4-5am & this is when the license was for only 2am.
- (c) Most licensed premises in the area end at 1am on weekends, this means there would be ample time to repair to Funky Brownz from all over Hornsey, Crouch End, Wood Green & other areas. By this time a large percentage will be already drunk.

Licence on Colindale bar to be reviewed after wave of violent disorder

7:40am Monday 13th April 2009 VIOLENT revellers flowing from a Colindale pub have forced police to call for a review of the premises' licence.

Officers have been called to **Ash Bar/Funky Browns**, in The Hyde, 11 times since February 13 to reports of violent offences, disorder and offensive weapons.

A report, to go before Barnet Council's Licensing Sub-Committee on April 20, shows one male has been stabbed and two police officers assaulted. It adds: "These have all involved people associated with the premises."

The application for a review has been made by the Metropolitan Police Service and it states that they are of the opinion **Ash Bar/Funky Browns** are associated with serious disorder.

Superintendent Dave Tucker said: "In recent weeks there has been a significant and real increase in disorder and alcohol related offences at these premises."

They have outlined a series of conditions to "greatly reduce" trouble including reduced opening hours and permanent security guards on the doors.

One resident, who lives near to the bar but did not want to be identified for fear of reprisals, said property is regularly damaged by late night drinkers he has seen coming from the premises.

He said: "No-one should feel under siege in their own home.

"The problems have been going on for months and we just feel that enough is enough.

"It is the owner's responsibility to make sure people when they leave, do so in an orderly fashion and don't smash up property, as well as making sure trouble makers don't hang around there."

The hearing will be held at Barnet House, in High Road, Whetstone at 7pm.

We refer to the above matter and to a forthcoming review hearing of the license to operate a pub to be heard in April 2009 by your offices.

We act for the Landlord of a tenant at 8 Rhodan Gordon Court, The Hyde, London NW9 6LE, the Westway Housing Association. The Westway Housing Association is an adjoining land owner of the Ash Bar and Funky Brownz at 63-65 The Hyde.

We have been instructed to address a letter to you for your consideration ahead of the above mentioned review of the Ash Bar and Funky Brownz licence to operate a pub.

Please be advised that our client and its tenants are concerned about noise nuisance emanating from the pub at all hours, particularly late at night. They are also concerned about dogs housed at the pub barking at all hours of the day and night, thereby disturbing our client's tenants.

On 28 August 2008 our client applied to the Barnet County Court for an Injunction Order pursuant to Sections 153(a) or (d) of the Housing Act 1996. We enclose herewith a copy of this application and attached witness statements for your attention.

The Order that our client sought in relation to the above mentioned hearing was an Injunction requiring the owners of the Ash Bar and Funky Brownz pub to place noise monitors near a cage, which at that stage had accommodated dogs at the property in order to detect the level of noise caused by them and also amongst other things, prohibiting the owners of the pub from threatening residents or otherwise engaging in activities that may affect the quiet enjoyment of anyone residing in the vicinity of 3-65 The Hyde, West Hendon, NW9 6LE.

At a hearing in the Barnet County Court on 28 August 2008, the owners of the pub gave the court an Undertaking promising to move the dogs inside the pub after 9pm until 12 noon at weekends and 7.30am during weekdays.

At a further hearing on 3 October 2008, the owners of the pub agreed to continue to house the dogs in the enclosure within the boundaries of the pub, between the hours of 9pm until

We have been instructed that a resident of our client at Rhodan Gordon Court, 69-71 The Hyde, London NW9 6LE has between the period 12 November 2008 and 26 January 2009 complained to our client about further noise nuisance caused by the dogs at the pub, and in particular complaining about the dogs barking at all hours of the day and night, so that she is unable to sleep.



NEW PREMISES LICENSING APPLICATION OBJECTION NO5 TOTTENHAM LANE, HORNSEY N8 9DL[FUNKY BROWNZ].

My husband and I wish to object to the proposal to change the use of "The Wishing Well" public house on Tottenham Lane, to a night club.

We understand that the proposal is to reopen the premises as a "hip bar restaurant with a shisha smoking lounge and dance floor', to be named "Funky Brownz'. We understand and a point of deep concern that the intention is to have the premises open until 4.30am on fridays and saturdays, 2.30am on Thursdays and 1.30 on the other days.

We are suprised not to have received any correspondence from the council regarding a licensing review or plans to enlarge the building and have learnt about the proposals from an article written in the Hornsey and Crouch End journal on the 2.7.09. Of course this does not give us the opportunity to prepare and communicate our objections.

We have been residents in Gisburn Road for fifteen years. As you may know this is a quiet residential street within 200 yards of the proposed night club. We have two young children. We are naturally concerned about the potential impact such a proposal could have on our family. These include the following:

- 1. The possibility of late at night disturbance caused by inconsiderate users of the club causing noise and disorder and the impact that would have on our children and ourselves.
- 2. I imagine the facility would attract people from other areas with Funky Brownz looking to have a healthy and thriving business encouraging what could turn out to be coach loads of people using and enjoying the club, further exacerbating the point made above.
- 3. Complaints have been made in the past due to noise, disruption, criminal damage and even fighting in local residents gardens caused by customers of the former public house. The fear is that this would reoccur and quite possibly be

worse with the chance to drink some nights until 4.30 am.

- 4. We are also concerned about the possibility of criminal damage occurring to our cars and property, drink driving, anti social toilet behaviour, litter and police activity.
- 5. Although the current owner has ensured security, we are concerned that this ensures the nightclub is safe and undesirables are evicted from the premises and their anger and disappointment may well be acted out on our door step.
- 6. Parking is already an issue in this area with the council refusing to grant a residents only scheme, the parking demands from the club would only add to an already intolerable situation.
- 7. We believe the club would have a negative impact on the resale of our property, if not to the value, then most certainly make the property less attractive, due to it's close proximity to an early hours night club.

I am objecting on the grounds of preventing crime and disorder, in my concern for public safety, in a desire to prevent public nuisance and in preventing harm to the children in this quiet, residential, family area. I imagine such a nightclub would be suited to a busy town centre and therefore object to it's proposal strongly.

Firstly, thank you very much for bringing this matter to our attention and giving me the opportunity to voice my concerns.

I would like to make an objection to the application made by Funky Brownz on the basis of Prevention of Crime & Disorder, Public Safety and the Prevention of Public Nuisance. There has been very noticeable reduction in all three of these licensing objectives in the recent period where the public house has been closed, suggesting that it is the main root cause of some of the following problems noticed and experienced on Ribblesdale Road N8:

- Damage to property (recent burnout of parked car on street)
- Litter
- Police activity (and hence the by-product of noise and commotion)
- Physical intimidation (not experienced but was aware of its presence through neighbours)
- Public Nuisance (this is by far the largest issue for me, with Friday and Saturday nights being particularly disrupted by customer noise between around 1am and 3am)

It seems to me that the area is very much a residential area, and so is not suitable for such an establishment to be set up.
