The Licensing Authority has concerns relating to your clients applications. We are aware that there has already been two unauthorised music led events at the venue that have generated complaints.

The venue itself has a history that shows that it is not suitable to be used for regulated entertainment. Whilst we appreciate that the application is not seeking regulated entertainment it may still benefit from the exemption to offer regulated entertainment if the ability to offer alcohol On sales is granted.

The venue is not suitable for live or recorded music offered to entertain customers. The premises may possibly be able to offer low level background music at best in order to ensure that the prevention of public nuisance objective is promoted.
