## 1. Executive Summary

- This year, a total of 39 questionnaires have been completed – the majority came through the council's online survey platform, one by email. Respondents were asked for their views on growth proposals, savings proposals and capital proposals.
- Respondents to the consultation strongly supported growth proposals relating to crime prevention, clean air zones and investment in our public realm including cycling and walking infrastructure, roads, pavements and streetlights. Residents were asked for any proposals they thought we should not progress. Topics included plans investment in the New River Sports Centre, climate change prevention and investing in digital advertising.
- When asked about savings proposals, respondents strongly supported proposals relating to debt recovery initiatives, improved efficiencies and Extended Provision (Lodges) and use of Council owned buildings as temporary accommodation. Residents were asked for any proposals they thought we should not progress. Topics included plans for low traffic neighborhoods and controlled parking zones, adult social care and waste services
- With regards to capital proposals, respondents strongly supported proposals relating to improved debt recovery, asset management of council buildings and the walking and cycling action plan. Residents were asked for any proposals they thought we should not progress. These included plans for Ward's Corner, digital advertising and traffic route management.
- Residents were asked for any changes or proposals that they would like to see in the future which might save money. Respondents suggested digital initiatives, more traffic wardens; digital transformation; both insourcing and outsourcing our workforce; and, implementing revenue raising activity. There were also suggestions about council contract management and working with other Local Authorities to create multiservice contracts.
- Residents were asked for feedback on any changes or proposals that they would like to see in the future which would help to make Haringey a more equal borough. Responses included: investing and targeting public services, having a needs-based solution for waste, prioritisation of active travel, public highways and carbon reduction; and, workforce.

## 2. Introduction

### 2.1 Introduction

The budget proposals for **2023/2024** have been subject to a formal public consultation. This report sets out the findings from the Council's consultation on its budget for **2023/24** which also refreshes its Medium-Term Financial Strategy (MTFS) to cover the period up to **2027/28**. This report presents the findings of this consultation, to inform the final decision on the Council's budget for **2023/2024**.

### 2.2 Technical Details & Method

The general consultation consisted of an online questionnaire published on: <https://www.haringey.gov.uk/local-democracy/policies-and-strategies/your-haringey-your-future> together with a budget consultation booklet which provided background information about the council's budget setting process and the financial challenges the council faces. Paper copies were made available at libraries across the borough.

The consultation was widely promoted via the council's resident magazine, Haringey People Extra, the council's business e-newsletter, the council's website, Twitter as well as through various partners.

#### 2.2.1 Questionnaire Design

The questionnaire was developed to ascertain residents' views on the proposals put forward in the budget. In particular, the consultation invited views on the:

- Proposals which respondents supported the most.
- Any other Proposals which respondents supported (the consultation also asked respondents to provide their reasoning).
- Any proposals which respondents thought we should not proceed with.
- Suggestions for ways in which the council could include to save money.
- Comments outlining whether respondents thought individuals with Protected Characteristics may be impacted by proposals.

#### 2.2.2 Questionnaire Analysis

A number of themes arose from the consultation. These are reported in greater detail where they were raised repeatedly by different respondents to the consultation. The number of respondents for other themes were too low to draw any clear conclusions.

### 2.3 Response to the Consultation

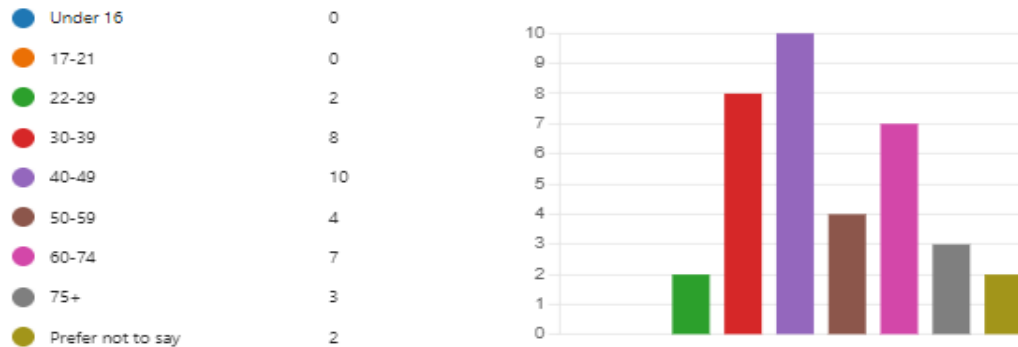
A total of **39** questionnaires have been completed – the majority came through the council's online system and one via email.

The equalities profile of responses is outlined below:

### Which age group applies to you?

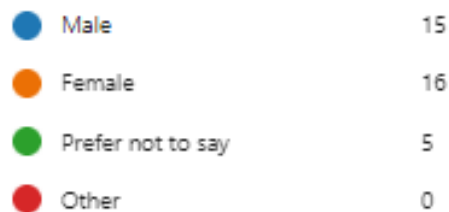
The majority of respondents who answered this question were aged between **40-49**.

8 respondents selected the **30-39**, while a further 7 individuals self-identified as **60-74**. There were 0 residents below the age of **21** who responded



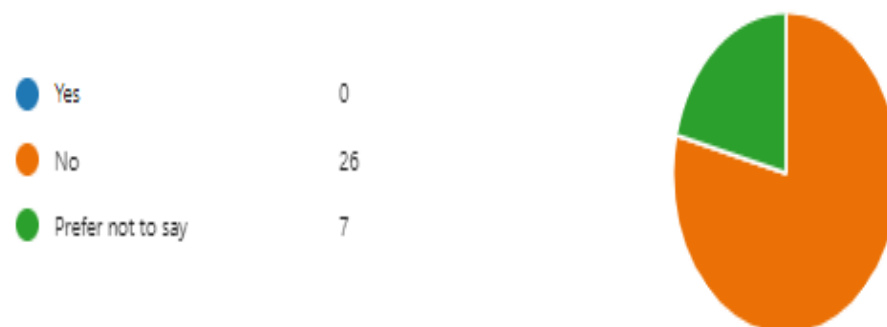
### What best describes your sex?

This question asked respondents to describe their sex. Of those who responded, the results are balanced with **16** responses from female and **15** from men. **5** respondents preferred not to say.



### Do you consider yourself to be Trans?

Trans is an umbrella term to describe people whose gender identity is not the same as, or does not sit comfortably with, the sex they were assigned at birth. 26 respondents selected **No** whilst **7** respondents preferred not to say.



### *Do you consider yourself to be disabled?*

This question asked respondents to identify whether they have a disability or had any long-term mental or physical conditions. As the graphs shows, the majority of respondents stated that they **do not** consider themselves to be disabled (**23**). **4** respondents did consider themselves to have a disability.

**9** respondents preferred not to say.

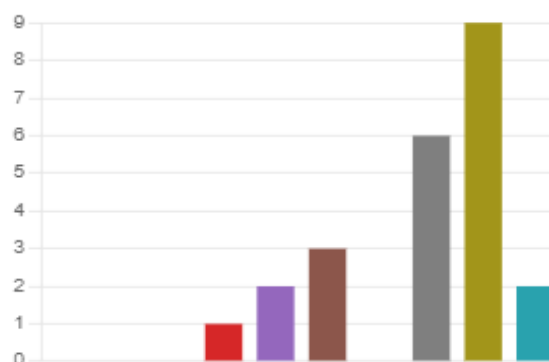


### *Disability – Which of the following impairment groups apply to you?*

### *National Identity – How would you describe your national identity?*

The majority of respondents to the budget consultation identify as being **British** (18) with 6 people identifying themselves as **English**. There were 2 respondents who selected **Irish** and 1 respondent who considered themselves as **Turkish** and 1 respondent who considered themselves as **Welsh**.

### *Ethnicity – What best describes your ethnic group.*

The majority of respondents to the budget consultation would describe themselves as being **British** (**18**). **6** respondents selected **English** and 2 respondents who selected **Irish** as their ethnicity.

3 respondents selected **other**

### *Sexual Orientation – What best describes your sexual orientation?*

The majority of respondents described themselves as **heterosexual/straight** (18), 2 respondents selected **bisexual** and 1 respondent selected **gay/lesbian**.

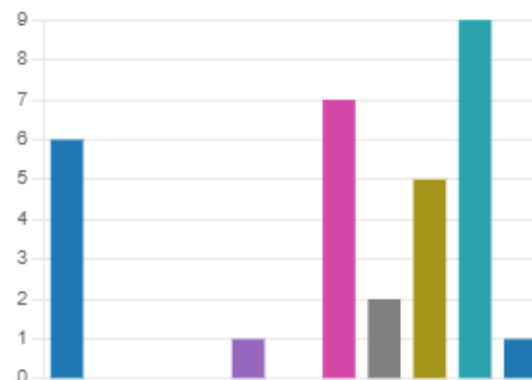
### *How would you describe your religious belief?*

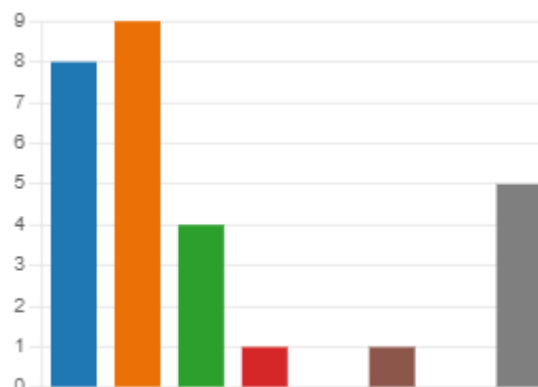


*Marriage and Civil Partnership? What best describes you?*

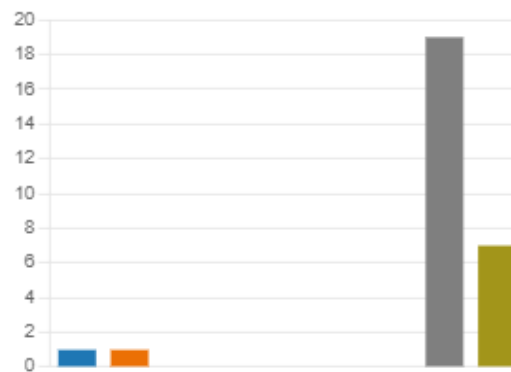


*Socio-Economic status – Are you on any form of Income Support?*

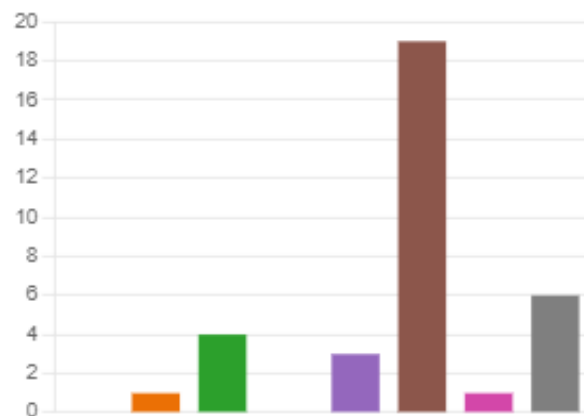


### *Socio-Economic status – What is your level of Education?*

### *Preferred language*

The vast majority of respondents selected **English** as their preferred language (**28**). There was 1 respondent for **Turkish, French, German** and other respectively. 1 respondent selected **Other**.



### 3. Detailed Findings

#### 3.1 Detailed Findings – Q1 – Which proposals do you support and why?

##### *Roads – LTN/CPZ*

There was a mixture of feelings about Low Traffic Neighbourhoods. Whilst some residents supported the aim of seeking to reduce car traffic and support active travel, others did not agree with the approach or did not feel it should be prioritised. Reasons given included that they were not felt to have reduced pollution and that they were disruptive to local residents.

*“...Low Traffic Neighbourhoods. Pay back the TFL money and abolish plans for the LTNs”*

*“....LTNs. They concentrate traffic on roads that cannot cope with the additional traffic.*

*They stop emergency vehicles. They reduce property values of homes outside the LTNs”*

*“....More should be spent on social care and education, less on walking, cycling and above all LTNs”*

##### *Clean Air Zones*

There was support for Clean Air Zones, particularly in areas where Low Traffic Neighborhoods may not be feasible.

*“Cleaner air, for obvious reasons”*

*“Clean Air Schools Zones: important to implement measures where School Streets are not feasible”*

##### *Civic Centre*

Respondents sometimes expressed doubts about the value of plans to develop and refurbish the Civic Centre. A common theme was the of concern was the cost of the work. Other issues mentioned included it now being surplus to requirements given changes to the way council staff are likely to work in the future and that the money could be spent better elsewhere.

##### *Crime and Public Safety*

There was support for our plans to tackle crime.

*“I support hospitals and crime budgets”*

*“As residents, we do not feel safe living in Haringey with such a high crime rate and lots of homeless people and anti-social behaviour”*

##### *Wolves Lane: Market Garden City*

There was support for our plans to create a hub on Wolves Lane, however, one respondent felt an increased budget was required to support this work.

*“I am writing to support the Wolves Lane centre (the nursery, Palm House etc). I applaud their community work and am very pleased they have won lottery funding and that the Council have agreed to match this so that they can develop their site”*

*"I support the Wolves Lane nursery and market garden investment -- however I think a small contingency allowance is needed more immediately to keep the warm environment plants now at risk through lack of money for heating"*

## **Detailed Findings – Q2 – Which proposals do you not support and why?**

### **CPZ/LTNs**

There were concerns raised about Controlled Parking Schemes and Low Traffic Neighbourhoods. This centered on the impact they were having on traffic.

*"...My commute to/from work, shopping visiting friends, doctors/hospital appointments via public transport have been massively delayed and have massively disrupted my family life of quality time spent with them."*

*"...I feel that council has made a proper mess with the closure of the streets"*

### **Advertising space**

Comments were raised about the investment in street advertising. There were concerns over the financial viability as well as the aesthetics of the advertising boards.

*"...Large Digital Platform, they are electronic, cost a lot to maintain, as do the glass with Logit's Advertising boards by the bus stops - the big black pillar ones that are hard to see in dark; they are dangerous when glass smashes and they are expensive to maintain"*

*"Street advertising, it's ugly and takes up space"*

### **Waste**

There were concerns raised about savings related to the waste services review, although reasons for concerns were not included in responses.

*"The reduction in waste (£1.5 million spend)"*

*"Reduction of waste services"*

## **Detailed Findings – Q3 – Are there any other growth proposals, which you think we should have included in this budget, and why?**

### **Council Tax**

Some residents felt that council tax be covered for all residents, to reflect cost of living pressures. Others disagreed:

*"Council tax should be covered for everyone as we are in a cost of living crisis"*

*"Council tax could be raised by at least 1% more"*

### **Energy**

There were several comments related to the increased cost of energy. These included comments about ways to support individuals as well as how the council manages its own energy bills.

*“Help out energy bills!”*

*“Reduce energy usage in buildings and make your staff hybrid”*

### **Sports Facilities**

There were a number of calls to help provide affordable access to exercise for residents:

*“I would like to see more sporting areas for people to use, more play area for secondary age children, not just primary, wild play area to climb and jump, tennis wall so you can play on your own in the parks that are safe and patrolled by police”*

*“Put money back into a failing sports centre that the community uses for mental/fitness stability”*

**Detailed Findings – Q4 – Are there any changes or proposals you think we should consider in future which might save money, generate income or achieve even better value from council spend? E.g. through greater use of innovative technology.**

### **Roads and Parking**

Some respondents felt that parking enforcement could be better used to generate income.

*“You could enforce parking regs by putting more traffic wardens on the beat. Doesn't this generate income?”*

*“- Charge more for car parking, especially from visitors driving to the Borough and parking here, as well as from motorised delivery and commercial vehicles”*

### **Contracts**

Some respondents felt that the council could commission services and manage contracts differently or more effectively. This included a suggestion to work with other authorities on shared contracts.

*“... Bigger multi borough contracts for uniform services”*

*“Renegotiate Veolia contract as their crews are appallingly negligent”*

### **Waste**

Suggestions were put forward with regards to waste to ensure the council with a focus on more efficient collection schedules and commercial waste costs.

*“Smart garbage collection”*

*“Make local businesses pay more to access council-run services, e.g., businesses which creating waste should pay a bigger share to collect”*

**Detailed Findings – Q5 – We also have a commitment and responsibility to make Haringey a more equal borough. In considering our proposals, please let us know if you think there are ways that we can narrow the gaps in life chances and opportunities available to different groups of residents in the borough.**

### **Affordable housing**

There were calls for us to improve the affordability of housing ensuring that people can feel their homes are safe and can be managed.

*“Affordable housing”*

*“Housing is a key determinant of quality of life. Focus on ensuring that children and other living in rented accommodation have safe manageable homes”*

### *Exercise opportunities*

There were various comments on how the Council could help increase opportunities for people to exercise including cycling, both in outdoor spaces and gyms.

*“Making cycling easier for all groups has to be a good thing”*

*“Continue to maintain gym equipment in the park and keep parks usable for all, create new spaces for people to use and improve areas of cycling lanes*

### *Development opportunities*

Respondents also raised the potential for encouraging development as a way of creating more opportunities for local residents.

*“...More development and therefore opportunities. Encourage large firms or institutions into the borough through greater development”*

*“...The budget disproportionately underrepresents young professionals in the area who may not have children and don't have adult social care or housing needs. Young professionals like myself would therefore have liked to have seen more expenditure on regenerating Wood Green to attract more people into the area to spend and contribute to the local economy”*

### *Air pollution*

Reducing the negative impact on air quality of car use was seen by some as being an important equality issue.

*“Limit air pollution created by a minority of car drivers, which effects everyone”*

### *Haringey Council Staff*

Some respondents to the consultation wanted to see the council demonstrate its commitment to equality in the way it managed recruitment to council jobs and monitoring pay equality.

*“You need to give managerial jobs right people”*

*“Try to pay all council employees the London Living Wage; investigate and publish any gender, sexuality, ethnicity-based pay gaps”*

### *Targeted service delivery*

A number of residents felt that services targeting specific resident groups, parts of the borough, or which were more reflective of the level of need, would contribute to greater equality.

*“More and better services for elderly, disabled, and low income children/ low income family teenagers. Social care and SEND services have been cut to the bone”*

*“We require a needs-based solution on waste and enforcement solutions in the east of the borough”*

*“Agree with aim to tackle inequality in the borough”*

*“Fully support efforts to reduce this gap in east of borough”*

## **Detailed Findings – Q6 - Do you have any other comments on our proposed budget?**

Other comments included how the council spends its operational budget, managing its energy bills and investment in nature.

*“At home we are all trying to turn our heating down to save money, even pending any additional insulation measures.. Is the council doing the same in its offices?”*

*“Yes please plant fruit trees around our parks. And educate people for nature”*

This could be through investing in cleaner and safer streets, and to regenerate the high street/ shops and leisure activities and parks.
