Hello Daliah.

Thank you so very much for your email below.

Please see the questions/statements/objections also below.

I shall then forward you a further 2 images at a time, marking the subject as - images 1 and 2 then 3 and 4, etc, in all there are a total of 8 images.

I apologise for such lengthy objections/statement but feel it is the only way to get all covered.

A1) Proposing that 5 people/customers from the premises of 95 West Green Road are to stand outside on the pavement goes against the statement of the "Public Spaces Protection Order" that only 2 persons are allowed to gather!

Persons gathering on the pavement causes Pedestrians, Mobility scooters, Disability pusher/trolleys, wheelchairs, prams/pushchairs, issues unless the persons are confronted with asking them to move out of the way with the fear of being verbally abused perhaps even threatened with violence especially if inebriated, as already happens, as there is No enforcement of the "Public Spaces Protection Order" carried out. So when the pavement is being blocked by such people others who need to use the pavement cannot so end up having to walk in the road!

A2) The applicant states the cafe/restaurant is to be a family friendly place so why would a Late night alcohol license be applied for. Surely if a license is granted a reasonable time would be until 10.30.p.m. Especially as I understand it has also been stated/objected by a person named Kate Coulson that she has been informed by the Landlord that the lease is for Trading hours to be from 8.a.m - 10.30.p.m All the days of the week, so there would be a breach in the lease if those hours were not adhered to.

A3) Also it has been stated within the application for Off licence sales, so not just a cafe/restaurant, if Off sales are granted surely it will cause more people hanging around on street corners around the area and drinking alcohol so a further issue with ASB. There is already a Off Licence directly opposite 95 West Green Road.

A4) Take away sales of food will also cause further ASB with eating in the street/road etc and causing further rubbish with containers, bones, plastic cutlery etc. plus more noise from delivery drivers on scooters/motorcycles and cars that will probably be parking on the double yellow lines at least in Anchor Drive, because even now we have cars doing that. There will also be further cars parking in the council carpark with noise of slamming of doors.

A5) There is a sheltered housing premises at the end of Anchor Drive which has its own small carpark and we have a issue already with cars parking across its entrance where drivers either have to be asked to move or no drivers found as they have gone off to shop or get take away food. Plus there are cement bollards by the entrance to the flats that are constantly being smashed into, so at times having to repair them with a costing involved, again it will probably cause this to carry on and late

into the night and early hours of a morning if a late alcohol licence and off sales is granted and take away service is provided.

A6) The suggestion of a staff member of 95 West Green Road premises asking anyone who they feel is inebriated to leave and or to get a family or friend to take them home or get a taxi is ridiculous, as they would be risking verbal or even physical abuse.

A7) Also with placing any notices within the premises will more than likely just be ignored just as "The Public Spaces Protection Order" is ignored as that has never been enforced, yet if it had/was with the fines stated/imposed it would put a whole lot of money into the councils coffers to get ASB under control especially for its elderly residents.

A8) There has still not been stated exactly how many customers there will be in the premises, why is that?

A9) In regards to back ground music being played, has a limiter been put in place to set the noise level?

A10) There is already a late alcohol licence for the premises directly opposite 95 West Green Road where there is ASB with people gathered on the pavement and there is another 2 restaurants around a dozen or so shops that serve alcohol until midnight and supply take away foods and another 2 premises serving food inside and take away and alcohol one of which until 10.30.p.m. And another reasonable one until 5.p.m. Then around another 5 or 6 further down West Green Road so all within 1/4 mile, with so many places (10) is there a need for further and is it that these places are contributing to causing such extremely high ASB. Not forgetting the off sales of alcohol with a number of grocery shops also in West Green Road.

A11) It is well known that not only does the West Green Road area have high ASB and Crime rates, without further licences being approved/given.

A12) Who do residents complain to when there is and will no doubt be further occurring noise/ASB if a further late night alcohol and off license sales is granted/approved, because the noise team do not work every day and all hours of the day and night and we were informed a few years ago that they only dealt with noise from residential premises not commercial or indeed vehicles that have blaring music whilst parked with the doors open, so if that is still the case it would then fall to the police who are already are under pressure with the high crime where there has been a shootings, knifing and threats with machetes in this area of West Green Road in the last year.

A13) It has been stated that the applicant is a hard working gentleman, which I have no doubt he is, but there are many residents in Holly Court which is the Sheltered housing premises at the side of the premises of 95 West Green Road who have been hard working and are now retired or are unable to carry on their working life due to illness or disability and there are other residents around the vicinity who also are hard working so should not to have the worry/upset of further ASB/Noise.
