Report for Key/Non-Key Decision: Non-key decision

1 Describe the issue under consideration.

- 1.1 To report on the feedback of resident and engagement which commenced on 1st November 2022, closing on 23rd November 2022, reviewing the existing Crouch End A (CEA) Controlled Parking Zone parking places, parking restrictions and the operational times. Appendix 1 shows the extent of CEA CPZ and defines the boundary for the resident and stakeholder engagement area.
- 1.2 Having considered comments and feedback to the resident and stakeholder engagement, to seek approval of recommendations set out in Section 3, subject to outcome of the statutory consultation and detail design.

3 Recommendations

- 3.1 It is recommended that the Head of Service for Highways and Parking in consultation with the Cabinet Member for Tackling Inequality and Residents Services approves the following.
- 3.2 Retain the current Crouch End A (CEA) CPZ operational days and times - Monday to Friday, 10am to 12 noon for all roads within the CPZ
- 3.3 Approve the increase of existing waiting and loading restrictions (Monday to Saturday 8am to 6.30pm) to Monday – Sunday 8am to 6.30pm on Broadway Parade and Topsfield Parade.
- 3.4 To increase **lengths of ‘at any time’ waiting restrictions (double yellow lines) at the following locations** to improve safety, visibility, and accessibility for all road users.
 - Middle Lane Junction with Chestnut Avenue.

- Weston Park Junction with Elder Ave

4 Reasons for Decisions

- 4.1 The Councils adopted the parking schemes and resident engagement policy in April 2023. This sets out the intention to review Controlled Parking Zones (CPZ) every 5 years or earlier if there are representations from residents, ward councillors or where significant developments are planned for the area. The Crouch End A CPZ was last reviewed in 2011.
- 4.2 Analysis of the public engagement resulted in the council receiving 773 responses, from 5068 consultation documents hand delivered to residents of the Crouch End A CPZ area. This represents a 15.3% response rate which exceeds the minimum response rate of 10% required to make a decision. 58 of the responses received were from roads outside the defined CPZ area.
- 4.3 78.4% of those responding felt that changes to operational arrangements were not required. 53% of the same group of respondents do not find it difficult to find parking spaces in their road.
- 4.4 Analysis of the responses on a road-by-road basis indicates that not all roads indicated a preference for the current parking controls. 60.8 % of those responding from Elder Avenue, Fairfield Gardens, Fairfield Road, Felix Avenue, New Road and Weston Park (West side) indicated a preference for an increase to current parking controls. However, when analysing resident preferences on operational days and times, a majority preference (51% or above to enable a decision to be reached) for a preferred change in operational times, was not met. In line with the new Resident Engagement and Parking Schemes Policy, it is thus recommended to retain the existing parking controls (Monday to Friday, 10am –12noon) within Crouch End A (CEA) CPZ. Further information on public engagement analysis is provided in section 6 and Appendix 4.
- 4.5 In response to concerns raised during the engagement process to congestion and safety on the Broadway and Topsfield Parades, a recommendation to increase waiting and loading restrictions to include Sunday has been proposed to ensure the safety of all road users and ensure safe accessibility for essential services such as emergency services, public transport, and essential council services such as refuse collections.
- 4.6 The outcome of the public engagement **is supported by Haringey's Resident Engagement and Parking Schemes Policy.**

5 Alternative options considered.

- 5.1 No alternatives were considered as there are no proposals to modify existing **operational times. The decision is supported by the Haringey's Resident Engagement and Parking Schemes policy.**

6 Background Information

- 6.1 Crouch End A CPZ was first introduced in 2009, with the operating times - Monday to Friday, 10am to 12 noon. The CPZ was later extended in 2011 to address increased parking pressures being experienced at that time. The CEA CPZ has not been reviewed since 2011, a time frame of nearly 12 years. In that time Haringey has seen many changes with increases in population and new developments, along

with new challenges arising from climate change and sustainable transport initiatives across London.

- 6.2 The Crouch End A Review area was identified for inclusion in the 2021/22 sustainable works programme and a public engagement was programmed to be undertaken in November 2022.
- 6.3 This review has been undertaken to ask residents and business if they feel current operational times still meet their needs, along with other issues they feel may need **addressing**. **The review also meets Haringey's new 2023 Parking Schemes – Resident Engagement Policy pledge to review CPZ's every 5 years to ensure it still meets the needs of the community.**
- 6.4 It is important that we have safe, green travel to prevent our roads from being overrun by cars and to support active travel, which is the ambition of the Council. Parking supports Corporate Delivery Plan Theme 2: Responding to the climate emergency. Those measures will prioritise parking for residents, improve road safety, and enable improved kerbside space management whilst promoting sustainable forms of transport.
- 6.5 Controlled parking zones align with the Council's agreed Transport Strategy and support its objectives which include:
 - Improved air quality and a reduction in carbon emissions from transport and
 - A well-maintained road network that is less congested and safer
- 6.6 With the support of Ward Councillors, engagement material for the CPZ review was compiled and distributed to all registered properties within Crouch end A CPZ to seek resident feedback to understand if the community wanted and supported change to the current parking arrangements.

Public Engagement

- 6.7 Public engagement was carried out from the 1st of November 2022 until the 23rd of November 2022. The Council followed its usual engagement practice, which involved delivering public engagement packs which contained an information letter, questionnaire, and an area plan. These packs were delivered to all registered properties within the area. In addition, street notices were erected in every road to help raise awareness of the Council's proposal. Lastly, the engagement material and related information was uploaded onto the **Council's website with access to an online questionnaire** allowing responses to be submitted digitally. The engagement letter questionnaire and plan are provided in **Appendices (1 and 3.)**
- 6.8 Of the 5068 properties that received the engagement pack, the Council received 773 responses, a response rate of 15.1%. This response rate exceeds the Council's parking policy minimum response rate of 10%.
- 6.9 When asked, is it difficult to find parking space in your road?
 - 410 (53%) responded No,
 - 200 (25.9%) replied sometimes,
 - 153 (19.8%) answered Yes
 - 10 (1.3%) did not answer the question.
- 6.10 Of those who responded to question 4,

- 606 (78.4%) did not support an increase or change in parking controls in their roads.
- 159 (20.6%) supported an increase in existing parking controls
- 8 (1%) did not provide preference

6.11 In general, the overall majority indicated that existing parking controls in Crouch End A (CEA) CPZ are working well with current operational days and times – Monday to Friday, 10am to 12 noon.

Further analysis of responses on a ‘road-by-road’ showed that a sub-area situated around Topsfield Parade, Broadway Parade and the clock tower indicated a preference for an increase to the current operational hours. However, due to the split in preferences a majority preference (51% or greater) to a preferred operational time was not met. In line with the new parking policy, as no majority was reached the current operational times are proposed to be retained. See Appendix 2 for plan showing the sub area in detail. It is worth noting that council has previously received correspondence from some residents of Elder Avenue and Fairfield Gardens identifying parking pressures as a concern outside of current operational times can be difficult.

6.12 Four further roads; Christchurch Road, Harefield Road, Hatherley Gardens and Greig Close indicated a preference for increased parking controls. However, these were isolated in nature and could not be included within a cohesive boundary, therefore the current operational times are proposed to be retained.

6.13 A summary of figures for responses received from the sub-area is provided below.

- 31 (60.8%) support increase in parking controls
- 20 (39.2%) do not support increase in parking controls

6.14 When asked which operational days residents supported?

- 43.1% (22) indicated supported for Keep existing (Monday to Friday)
- 29.4 % (15) indicated support for Monday to Saturday
- 25.5% (13) indicated supported for Monday to Sunday
- 2% (1) no indicated support for any option

6.15 When asked which operational times resident supported

- 43.1% (22) indicated support for an all-day option (8am to 6.30pm)
- 39.2% (20) indicated support for two-hour operational time 10am to 12 noon
- 9.8% (5) Indicated a preferred an increase to a four-hour operational CPZ
- 7.8% (4) indicated a preference for other (self-selected) options.

6.16 A total of 443 comments were provided as part of the public engagement. A summary of received comments is provided in Table 1 below.

7 Contribution to strategic outcomes

- 7.1 Parking supports Corporate Delivery Plan Theme 2: Responding to the climate emergency. Those measures will prioritise parking for residents, improve road safety, and enable improved kerbside space management whilst promoting sustainable forms of transport.
- 7.2 Controlled parking zones align with the Council's agreed Transport Strategy and support its objectives which include:
- Improved air quality and a reduction in carbon emissions from transport and
 - A well-maintained road network that is less congested and safer
- 7.3 An increase in parking controlled hours on The Broadway and Topsfield Parades will offer residents and businesses on these roads more effective management of kerb-side space during operational times.

8 Comments of the Chief Financial Officer

- 8.1 This report seeks approval from the Head of Service for Highways and Parking in consultation with Cabinet Member for Tackling Inequality and Resident Services for the review of the Crouch End A (CEA) CPZ.
- 8.2 The full cost of this scheme is estimated to be £40k, including community engagement; inventory of existing site conditions; design and implementation. **This will be funded from the Council's approved Capital Programme as it was included within the Parking Implementation Plan.**
- 8.3 Future operation costs of Crouch End A (CEA) CPZ will be funded from the existing service revenue budgets.

9 Comments of the Head of Legal Services and Governance

- 9.1 Before reaching a decision to make the necessary traffic management order to implement a CPZ scheme, the Council must follow the statutory consultation procedures pursuant to the Road Traffic Regulation Act 1984 (as amended) ("**RTRA**") and the **Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) ("the Regulations")**. **All representations received** must be properly considered in the light of administrative law principles, human rights law and the relevant statutory powers.
- 9.2 The Council's powers in relation to the making of traffic management orders arise mainly under sections 6, 9, 45, 46, 122 and 124 and schedules 1 paragraphs 1-22 the RTRA
- 9.3 The power of a local authority to make an order regulating or controlling vehicular and other traffic is contained within the ambit of section 6 of the RTRA.
- 9.4 When determining what paying parking places are to be designated on the highway, section 45(3) requires the Council to consider both the interests of traffic and those of the owners and occupiers of adjoining properties. In particular, the Council must have regard to: (a) the need for maintaining the free movement of traffic, (b) the need for maintaining reasonable access to premises, and (c) the extent to which off-street parking is available in the neighbourhood or if the

provision of such parking is likely to be encouraged by designating paying parking places on the highway.

9.5 By virtue of section 122, the Council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and the provision of suitable and adequate parking facilities on and off the highway. These powers must be exercised so far as practicable having regard to the following matters: -

- the desirability of securing and maintaining reasonable access to premises.
- the effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve amenity.
- the national air quality strategy.
- facilitating the passage of public service vehicles and securing the safety and convenience of their passengers.
- any other matters appearing to the Council to be relevant.

10 Equalities Comments

10.1 The Council has a Public Sector Equality Duty under the Equality Act (2010) to have due regard to the need to:

- Eliminate discrimination, harassment and victimisation and any other conduct prohibited under the Act,
- Advance equality of opportunity between people who share the protected characteristics and people who do not,
- Foster good relations between people who share those characteristics and people who do not.

10.2 The three parts of the duty applies to the following protected characteristics: age, disability, gender reassignment, pregnancy/maternity, race, religion/faith, sex and sexual orientation. Marriage and civil partnership status applies to the first part of the duty.

10.3 The decision follows the outcome of a public engagement carried out to review current parking controls and whether a change to operational times is supported by residents and businesses in the area.

10.4 An engagement pack and a questionnaire with freepost envelope for returning the questionnaire was distributed to all households and businesses within the area. Street posters were placed in every road consulted and an online version of the engagement material **was made available on Haringey's website.**

10.5 The questionnaire also asked for disabled bay holders to indicate if they would like for their bays to be converted to a dedicated bay for their specific use only.

10.6 The introduction of the parking controls will prioritise parking for residents and businesses in the area and it will also make it easier for those with Blue Badges to park.



Review of Roads in Crouch End "A" Controlled Parking Zone (CPZ)

Introduction

We are writing to ask for your views on the existing Crouch End A CPZ. We would like to know if you have experienced increased parking pressures, whether the current operational times are managing parking demands and whether you feel a change to existing operational times is required.

Why we are engaging with you

In the 2020 Council approved CPZ policy, it sets out that the Council will aim to review permanent CPZs in the borough every 5 years. This is to ensure the current parking provision and arrangement still works for the community and ensuring operational days and times are still working well to manage parking stress.

To ensure that the Council manages any potential parking concerns, and in line with our 2020 CPZ policy, we are engaging with residents to understand which, if any, roads are experiencing parking pressure, what these pressures may be, and understand if residents and business would like changes to be made to the existing parking controls to better manage parking.

We will also be conducting a review of the Crouch End 'B' CPZ in parallel to this review. Evaluation of the results will be undertaken alongside one another.

The existing Crouch End A CPZ boundary can be seen on the attached plan.

Other changes on offer

To promote the uptake of electric vehicles we are considering new locations to increase the number of electric vehicle charging points/bays available in the borough. If you would like to request an on-street charging point, then please provide your address and the suggested location under Q9 within the questionnaire.

Dedicated disabled parking bays (those that can only be used by one vehicle registration) are one of the benefits being offered by the Council to help residents with severe walking impairments and those residents who cannot travel far to their vehicle. The bays are intended to provide eligible residents with easy access to and from their homes and ensuring there is sufficient room to manoeuvre in and out of their vehicle. What happens next?

Our estimated timeline to progress this project is detailed below.

- November / December 2022: Council Officers will undertake analysis of responses and prepare recommendations for reporting.
- December 2022 / January 2023: Officers will prepare a report with recommendations which will be submitted for a decision to a key officer in consultation with the relevant Cabinet Member.
- February 2023: We will write to you to update you on the outcome of the public engagement and decision. If changes are required and approved, we can then progress to statutory consultation.
- March / April 2023: Statutory consultation which includes advertising the necessary changes in the local newspapers allowing anyone to object to the proposals.
- May 2023: Officers will prepare a second report with recommendations on whether to implement the changes on the street. This decision is likely to be taken by the relevant Cabinet Member.
- June/July 2023: We will write to you again to inform you if any changes will be implemented and the timeframe for this.

Appendix 4 Public Engagement Analysis

CROUCH END 'A' CPZ REVIEW November 2022

Crouch End A CPZ area consists of some 5078 properties. A total of 773 responses were received. This gives a response rate of 15%.

This is a very good response rate and reflects the Council's policy of encouraging community engagement by offering the options of completing the survey either online or by submitting paper responses – assisted by freepost return envelopes.

A majority of responses to this consultation were submitted on paper.


