Reasons for the decision	<p>The Strategic Leadership in Modern Local Government programme presents an opportunity to upskill the Regeneration and Economic Development Programme Manager to in alignment with My Conversation objectives and aspirations. Previous managers from Haringey have attended this programme and have given excellent feedback.</p> <p>This particular opportunity allows the Council to benefit from a 12.5% bursary. Allowing for the bursary, the delegate fee is £4,895.63 (ex. VAT), plus £105.00 (nil VAT) for the ILM fee, which equates to a total contract value of £5,000.63.</p>
