Re: LICENSING ACT 2003: OBJECTION ON TENS NOTICE – SMOKY LOUNGE, 83 MAYES ROAD, WOOD GREEN, LONDON N22 6UP

On 15th August 2024 the Licensing Authority received from you, Bianka Mali, a notification in respect of proposed temporary licensable activities due to take place on 14th to 15th September 2024 at Smoky Lounge, 83 Mayes Road, Wood Green, London N22 6UP. The licensing authority has received an objection under section 104(2) of the Licensing Act 2003 ("the Act").

The objection which applies is indicated by an "X" in the following table.

You are reminded that under section 136 of the Licensing Act 2003, a person commits an offence if he carries on a licensable activity on or from any premises otherwise than under and in accordance with an authorisation; or if he knowingly allows a licensable activity to be so carried on. A person convicted of such an offence is liable to imprisonment for a term not exceeding six months or to a fine not exceeding £20,000, or to both.

Please inform us immediately if you wish to appeal to the Licensing Sub Committee.

Hi all,

To prevent Noise & Public Nuisance we propose several conditions to the applicant for the above TENS but unfortunately, they did not respond.

- 1. All licensable activities, playing music (live OR recorded) sell of alcohol and food must ceased at 00:30 hrs to provide adequate drink-up time for the patrons and the complete closure of the premises by 01:00 hrs.
- 2. The outdoor area/ beer garden of the premises must be closed as stated in the premises licence. All the premises licence conditions regarding the outdoor area/ beer garden apply during the TENS period.
- 3. No music (recorded or live) shall be played in the outdoor area/ beer garden of the premises.
- 4. No speakers or amplifiers shall be used to play any kind of music, announcements, MCing, or singing in the outdoor area/ beer garden after the closure of the area.
- 5. Any Music played in the premises shall not audible (nor any vibration caused by playing music) at or within the site boundary of any residential property.
- 6. The DPS will be present on the site every day to the closing time, throughout the event period ensuring the closure of the premises as state the above.
- 7. The DPS' contact number is provided and will be reachable in case the council officers require to reach him/her in case of noise complaint.
- 8. The DPS will take the necessary action advised by the council officers to reduce the level of noise and resolve the issue as soon as possible.
- 9. The DPS and the duty manager will respond and provided access/ entry to the premise to the council officers as and when a licencing visit is carried out by such officers.
- 10. The security officer must be reminded that he/she is not permitted to prevent entry of authorized council officers, as such an act is an offence under the Licensing Act 2003. The applicant / the DPS will be legally liable if such an offence occurs, and the council will take the appropriate enforcement/ legal action against The DPS, licence holder.
- 11. SIA badge holder (Security staffs) managing the crowd, to prevent any congregation, loitering by the patrons outside are within vicinity of local residential area, during the event and when the event ends, making sure the patrons leaving in an orderly and quiet manner.

Hence based in the ongoing history of noise nuisance emanated from the premises in particular the outdoor area in the back we recommend the refusal of the above TENS.
