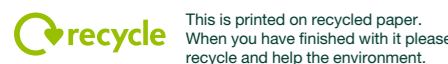

### Proposed 7.5 tonne Weight Restriction Zone – Palace Gates and Dukes Avenue Area

Dear Residents and Traders,

Further to on-going consultations and correspondence regarding heavy goods vehicle issues, we are proposing to introduce an area-wide 7.5 tonne weight restriction. The aim of the scheme is to discourage Heavy Goods Vehicle (HGV) through-traffic and improve the local environment and road safety in your area.

#### Our proposals

A decision has now been made to proceed to the statutory consultation stage for the introduction of the weight restriction. This shall consist of gateway signage on all exits and entrances from the zone clearly stating the restriction. The prohibition shall legally prohibit vehicles over the weight of 7.5tn (except for access only) to manoeuvre through your residential roads.

#### Have your say

We are required to enter into a stage of consultation known as statutory consultation. This is the legal part of the process and takes the form of a public notice advertised in the local press, London Gazette and visible locations within the area to inform of the council's intentions.



INVESTOR IN PEOPLE

The legal notice sets out the Council's intention to prohibit HGV movement through your area, this notice will be advertised on **30 July 2009** and provides a 35-day consultation period for interested parties to make representation regarding our proposal. The closing date for comments is the **3 September 2009**.
