Background

- In November 2020, Cabinet approved the <u>School Street Action</u> <u>Plan</u>. An updated <u>School Street Plan</u> was subsequently approved in June 2023
- 2. The key objectives given in the Plan for implementing School Streets are to:
 - a) Encourage active travel
 - b) Reduce pollution
 - c) Reduce car use and congestion near schools
 - d) Reduce road danger and improve safety for pupils and parents/carers travelling to and from school



A School Street is typically a road (or roads) outside a school with a restriction upon motorised traffic at school drop-off and pickup times

Report objectives

- 1. Summarise the feedback received to four proposed School Streets, consulted upon during 2023 & 2024
- 2. Assist in the decision-making process when deciding whether to introduce the School Streets

All four projects were subject to informal public engagement which ran for three weeks with late responses accepted for one week

- SS48, SS50, SS45: 11 July to 21 August 2024

 - 3. Postcards handed out to parents / children at the school gate




Overall number of responses



Respondent groups (Q6)


- In Q6, respondents were asked in what capacity they were responding.
- Respondents could tick more than one box (for example, they might be a resident outside of the school street *and* a parent of a child at the school) and so the total count <u>will add up to more</u> than the individual number of responses.
- The most common group selected (257) was 'parent / carer of a child that attends this school' followed by 'resident within the proposed School Street' (228).
- Some caution should be applied when analysing answers to this question. The response to Q6 has been cross-referenced against Question 10 (postcode) which shows that a significant number of respondents did not understand the proposed boundary of the proposed School Street. For example, at Coldfall Primary, 109 respondents to Q6 said they were a "resident within the proposed School Street" but according to the postcode given in Q10 fewer respondents (93) actually have a property with a postcode within the proposed School Street.

Overall view on all proposed School Streets (Q2)

- Across all four projects, 38% of respondents were positive or very positive about the proposals and 58% were negative or very negative.
- It is, however, important to consider the results on a project-by-project basis as they are discrete schemes with considerable variation in response rates within them.



Overall views on the proposed School Streets by project area (Q2)



- . This proposal is to provide a new School Street near the school's Everington Road entrance. The school already has a School Street adjacent to its Coldfall Avenue entrance (SS04)
- Mixed views on proposal with a significant number (35) of comments (from those who were ٠ neutral or negative about the School Street) saying the proposed hours were too long. The proposed hours of SS50 were aligned with existing SS05 however, in view of comments (and it is a different set of streets) it is recommended that SS50 has shorter hours of 8:30-9:15 and 2:45-3:45. This has been discussed with the school who support this.
- Significant number of comments saying the proposed School Street is too large however . engineers have reviewed the design and a smaller proposal is not possible without either (a) creating dangerous U-turn points or (b) excluding Hill Road and the eastern sections of Everington Road and Marriott Road. Many pupils use Everington Road to reach the school, therefore such a revision would not bring the benefits that the School Street aims to deliver. Consequently, a smaller zone is not recommended.




- This proposal is to provide a new School Street near the school's Stainby Road entrance. The school already has a School Street adjacent to its High Cross Road entrance (SS18).
- Mixed view on proposal with significant proportion of residents concerned about disruption School Street may cause (it is noted that those living within SS54 would be entitled to exemptions) followed by a significant number of respondents sharing the view that that proposal will create safer and healthier streets for children
- Officers are aware that the location suffers for existing parking and congestion problems at school times (see cover photo on page 1), exacerbated by the cul-de-sac layout of Stainby Road
- Recently constructed Mulberry House and Chalkley House were omitted in the proposal from being eligible for an exemption. However, as their access is via Stainby Road it is recommended that they are included





Haringey School Streets

School streets have the potential to transform public spaces outside schools to create better environments for everyone, and in particular, for children. School streets are designed to:

- Encourage pupils, parents and carers to walk, wheel and cycle to and from school
- Improve air quality by reducing the number of pollution emitting vehicles driving on roads around schools
- Reduce the risk of children being killed or seriously injured in a road traffic collision on their way to and from school
- Reduce vehicle congestion on roads around schools and provide more space for people

High volumes of polluting vehicles and young children sharing the same space is not a good combination, and so the London Borough of Haringey plan to create a school street for every feasible school in the borough, to benefit children across the borough. In preparation for the implementation of school streets, a series of pop-up engagement events were held outside primary schools in Haringey to inform parents and pupils about the proposed changes to the streets around their schools. Parents and pupils were encouraged to participate in a public consultation which ran from 11th July to 21st August 2024.

Engagement events were held at:

- Welbourne Primary School on Tuesday 16th July
- Bounds Green Primary School on Wednesday 17th July
- Coldfall Primary School on Thursday 18th July

This summary report highlights anecdotal outcomes from each engagement event and should be read in conjunction with the results of the public consultation.




Welbourne Primary School

A pop-up engagement event was held at Welbourne Primary School outside the Stainby Road entrance on Tuesday 16th July 2024. The objective of the engagement event was to inform parents and pupils about the proposed school street and to advertise the public consultation.

The engagement event also provided an opportunity for pupils, parents and carers to ask questions about the proposed school street. Comments received included:

- A sensible proposal which builds on the existing school street on High Cross Road.
- Pupils were generally supportive of the proposal, with some voicing concerns around road safety and commenting that they had seen collisions involving children on Stainby Road.
- Some parents said the School Street would be inconvenient for those who live further away or have to do multiple drop offs and are therefore more dependent on their car.
- Overall the feedback was positive with parents and pupils supportive of improved road safety and improved air quality to the benefit of everyone in the local community.



Plan of proposed school street on Montague Road and Stainby Road




Bounds Green Infants and Primary School

A pop-up engagement event was held at Bounds Green Infants and Primary School on Wednesday 17th July 2024. Although the school street is proposed to be on Park Road, parents and pupils were engaged at both the Park Road and Bound Green Road school gates to increase the amount of participation.

Leaflets were distributed to pupils, parents and carers to promote the public consultation. The engagement team also had informal discussions and answered questions about the school street. Comments received included:

- Some school staff who drive to work raised concerns about being unable to access the staff car park, which is accessed from Park Road, and sought assurance that they would be exempt from the restrictions.
- Positive feedback and recognition of the road safety risks to children on Park Road and also Bounds Green Road given the speed and volume of traffic.
- Despite being located outside the scope of the school street, concerns were also raised about the safety of crossing the A109 Bounds Green Road/B106 Durnsford Road junction.



Plan of proposed school street on Park Road




Coldfall Primary School

The third pop-up engagement event took place at Coldfall Primary School on Thursday 18th July 2024, with engagement focused on pupils, parents and carers entering via the Everington Road gate.

The objective of the engagement event was to inform pupils, parents and carers about the school street area proposed for Everington Road, Hill Road, Steeds Road, Barrenger Road and Marriott Road. A school street is already in operation on Coldfall Avenue. Comments received included:

- Some parents and school staff commented that the timings were felt to be unnecessarily long. It was suggested that a maximum of an hour at the start and end of the school day would be sufficient.
- Clarity was sought around who would be eligible for exemptions, given that the proposed areas includes five residential streets.
- One local resident raised concerns about the availability of blue badge parking on Everington Road, commenting that more spaces were needed.
- Concerns were raised about the impact on traffic flow and parking on streets outside the proposed area, including Coppetts Road, Sutton Road and Wilton Road.







Motor vehicles without an exemption, including visitors, tradespeople or delivery drivers are not permitted to drive into the School Street during operational times. But no exemption is required to drive out of a School Street, eg. those vehicles that were already parked when it came into operation.

Why is the Council considering a School Street?

These proposals are part of Haringey's plan to improve air quality, children's health, tackle the climate emergency and to make it safer and easier for children to walk and cycle. The council has been working with schools across the borough and has delivered 34 School Streets to date, including in adjacent High Cross Road (SS18) which has been in operation since April 2021.





I am writing to you to provide information about a School Street that is proposed in this area and to invite you to share your views as part of this consultation.

What is a School Street?

School Streets transform roads to create a better environment for children to walk, cycle and wheel to school.

How do School Streets help?

When a School Street is in operation, the road temporarily becomes a Pedestrian and Cycle Zone, at school drop-off and pick-up times.

By temporarily closing the road to motor vehicles at the start and end of the school day, School Streets help by:

- Reducing traffic outside the school, which reduces emissions and makes the air around the school cleaner at peak times for children
- Making it safer to walk, cycle, scoot, and wheel to school. Children will benefit from increased physical activity on their journey to and from school
- Reducing traffic congestion and parking problems outside the school and reducing road danger

Residents and businesses can apply for exemptions (details overleaf), giving them the ability to drive into the School Street if needed. Emergency service vehicles have access at all times.

What is being proposed?

The proposal is shown on the enclosed plan and is summarised as follows:

- Church Road, James Place and Brereton Road (between Church Road and Orchard Place) proposed to become a School Street that would operate:
 - o Term time only
 - Monday to Friday
 - 8:15 to 9:30am and 2:30 to 3:45pm
- Motor vehicles (cars, vans, motorcycles etc.) will not be allowed to enter the School Street during the above times <u>unless</u> they had been issued an exemption (see details below)
- To inform drivers, we will install traffic signs and send updates to sat-nav companies
- Motor vehicles that enter the School Street without an exemption, during operational hours, will be identified by camera and may be issued a Penalty Charge Notice (PCN)
- No one needs an exemption to drive out of a School Street. You only need an exemption to drive into the School Street during operational hours
- School Streets remain open to people walking, cycling and wheeling
- Emergency services will always have unhindered access

Who is eligible for a School Street exemption?

Appendix A3

If the scheme goes ahead, the following groups would be eligible to apply for an exemption:

- Residents or businesses who have an address within the School Street (see note below) to a
 maximum of two vehicle registrations per property
- Blue Badge holders who require access to the School Street
- Pupils with a disability that prevents them walking or cycling to school
- Medical practitioners visiting someone with an address in the School Street
- School vehicles transporting disabled children

Note: properties within the boundary of the School Street would be eligible for a resident or business School Street exemption. Those properties are outlined in blue on the enclosed plan.







		I notice on your consultation map that Amethyst Close is highlighted as being a private road. It is actually a Clarion housing estate, with a lot of social housing. There are disabled and elderly people living here who sometimes need to be driven to places like hospital appointments, by relatives, or in taxis which will not have School Street exemptions. Surely, if you were going to create a School Street next to Bounds Green School on Park Road, you could end the zone before it reaches Amethyst Close instead of running it all the way up to Edith Road. As then anyone driving from Amethyst Close would at least be able to get in and out via Park Road/Edith Road exit, instead of being trapped in Amethyst Close.
		My other objection to this proposal is that I do not accept your reasons for introducing it. They sound like generic reasons that do not reflect the reality of the environment around Bounds Green School. Haringey Council has reduced air quality near Bounds Green School by introducing LTNs elsewhere which have pushed significantly more car traffic onto Bounds Green Road. So pupils at Bounds Green School have already been exposed to more pollution because of a decision made by Haringey Council. But now you are pretending that stopping a few cars from driving down Park Road for two hours a day will make any difference to the level of pollution. If Park Road were a rat run you could make that argument. But it isn't busy. It only gives local access to what's effectively a cul de sac blocked in by the railway tracks.
		Which brings me to your claim that the School Street would reduce congestion. There is no issue with congestion in Park Road because the only people who drive down there are people who live on this side of the railway tracks, delivery drivers or parents picking up their children. So you're claiming to solve a problem that doesn't exist and causing unnecessary disruption to residents in the process. I accept that having fewer cars on roads reduces road danger to children however, seeing as the kids have to navigate Bounds Green Road to get to their school in the first place, I'd say that the danger is on the main road more so than on Park Road - especially since Haringey Council increased the level of traffic on Bounds Green Road by introducing LTNs.

Especially as the school tries to encourage a no drive zone and to make parents walk their children to school, to no avail as it continues. A camera has even had to be put up to stop people parking on zig zags even when told not to. It's been shown time and time again that the parents do not listen and will certainly accomplish. Apologies for the long message but this really is a massive problem and I'm so happy that this proposal has happened and will be delighted when it finally gets put into action.

The increased difficulty in getting to work on time may deter potential new staff from joining our school and could lead to current staff seeking employment elsewhere. This is a risk we cannot afford to take, especially given the vital role teachers play in shaping the future of our community.

We are already struggling with recruitment and retention in education and this proposal will make it even more difficult. I am not completely opposed but please can the time be moved to 9 am? That way teachers and teaching staff will be able to get to work without unnecessary stress. Many teachers have young families and are traveling from a distance to get to school. They have to drop their children to childminders and breakfast club facilities elsewhere. To expect them to be able to get to school before 8 am would be impossible. This proposal does not consider how difficult and impactful it will be on our school community. Please reconsider.

However, surrounding roads, such as Coppetts Road, Wilton Road, Sutton Road and Creighton Avenue, which are roads that suffer already with significant traffic and which are already used as rat runs and car parks by parents driving their children to schools, including Coldfall, will suffer from increased car traffic issues. All of the problems that I have marked as frequent in response to question 3 are all significantly worse during Coldfall school drop off and pick up times. On our roads, we too would like less traffic disturbance and pollution. Surely, with all aspects of traffic safety in mind, the better solution is to actively encourage parents to walk and use public transport whenever possible, as opposed to using their cars. This strikes me as a better option than pushing increased traffic into other residential roads, which are already suffering in terms of pollution and safety as a result of ever increasing traffic and a great number of speeding cars. It feels like the council on this occasion is merely shifting traffic to surrounding roads. Coppetts Wood school in Barnet was accessed for a schools street but this was deemed not possible due to the rerouting of too much traffic.
