



Car Clubs Consultation Data Analysis February 2024

Overview

Car clubs provide vehicles to hire on a short-term basis and allow people who do not own a vehicle to use one at their convenience, for example for purchasing bulky or heavy items that would be difficult to carry on public transport. Car Clubs provide residents and businesses with the option to make more sustainable transport choices.

There are currently two main models of car club scheme – the "Fixed Point" model and the "Free-Floating" model. With the Fixed Point model each car has its own designated bay and has to be returned to that bay by the end of the hire period. More recently, several companies have introduced the Free-Floating model, where a vehicle does not require a specific bay as it can be picked up and dropped off in any bay permitted by a participating local authority.

For local authorities, car clubs can help deliver against wide-ranging objectives which include:

- achieving net zero targets
- improving air quality
- increasing vehicle occupancy rates
- reducing parking pressures and congestion
- offering a sustainable transport option that can fill gaps in public transport provision

Car clubs are becoming more popular - with a total of 767,899 UK car club members in 2023; an increase of 38% since 2020. To accommodate this growth, the number of total car club vehicles has also increased. There are 5,167 car club vehicles operating across the UK.

Car clubs have operated in Haringey since 2008 with currently 74 fixed car club bays across the borough operated by ZipCar and three spaces located on private land and operated by Enterprise.

To ensure that car clubs in Haringey meet the needs of residents and provide best value, the council is planning to enter into a new long-term agreement with one or more operators to deliver these services.

Responses to the consultation exercise will be analysed and feedback incorporated into the future 'ask' of car club operators.


Consultation Analysis

The consultation was conducted usng 'Commonplace' software. As with all such consultations; samples are 'self-selected' i.e attract those who are already car club members, or who have an interest in the subject. When it is important to have a statistically representative views; then we would use market research techniques.

Given that only a small number of Haringey residents and businesses use, or are familiar with, car clubs; then a key ongoing challenge is how best to promote and encourage car club use in the longer term.






4a Other reasons for not being a member:
