SS15	Objection	I wholly object to this proposal as this proposal does not take into consideration of the strain it brings to the existing parking and the additional traffic it brings for parents and carers collecting their kids from the school. The area is already over populated and with removing additional bus lane times impact on children being drop off and pick up to the school.
SS15	Query	 -the access arrangements are due to change for Brereton Road from High Road and to be restricted next Monday. As well as the bus lane access outside the school to also be closed for an indeterminate amount of time. Has the implementation date taken this into account? - Could we get clarity which addresses would be eligible for the school street permit. - Finally, advance and clear signage on High Road before the approach with Church Road would be something I'd like consider.

SS48	Objection	am writing to formally object to the proposal to exclude Tredegar Road from the list of roads eligible for an exception permit for the street school initiative, scheduled to take place from 8:30 am to 9:30 am and 3:00 pm to 4:00 pm, Monday to Friday. As a resident of Tredegar Road, I believe this decision would have a severe negative impact on both the residents of Tredegar Road and the surrounding area, particularly Palace Road.
		Firstly, Tredegar Road is the main access route to my property and to the properties of many other residents. The exclusion of Tredegar Road from the exemption scheme would force us to navigate a much more complicated and time-consuming route, causing significant inconvenience, particularly during the proposed times when traffic is already expected to be heavier due to the street school activities.
		Moreover, I am concerned about the significant increase in traffic that will be diverted onto Palace Road, an adjoining residential street. Palace Road, which is already a busy road, would likely experience even greater congestion, as parents and other commuters use it as an alternative route. The resulting chaos and disruption to the flow of traffic would not only cause inconvenience but could also pose safety risks, especially for pedestrians and children. The added strain on Palace Road, which is not equipped to handle such an influx of vehicles, will likely lead to gridlock during critical hours, further exacerbating the situation.
		I urge you to reconsider the decision to exclude Tredegar Road from the exemption list. Instead, a more balanced approach should be considered that addresses the concerns of local residents and ensures the safety and convenience of all road users in the area. Allowing Tredegar Road to remain eligible for an exception permit would help mitigate the negative consequences of the street school scheme and prevent undue strain on nearby roads, particularly Palace Road. SS48	Objection	I am writing to formally object to the proposed School Street scheme for 2024-T44 Bounds Green school scheme, as it is clear that the concerns of residents have not been taken into account. Instead, the changes appear to be designed primarily around businesses, with little regard for those who actually live in the area, and creates serious traffic and safety concerns. While I fully support school zones and their intention to improve safety, I am very disappointed that the initial feedback from residents within Park Grove and Tredegar Road has been overlooked. Residents living off Park Road on Tredegar Road and Park Grove, are particularly affected, as we remain unable to drive down Park Road under the proposal. This is an unreasonable and impractical restriction that fails to consider the daily needs of those who live here. It is unacceptable that businesses seem to have been accommodated, while residents are left with no solution. Residents of these streets must still rely on access routes that are now heavily restricted through the proposed plans. Park Road, which has been designated as the school street, is essential for access to and from Tredegar Road/ Park Grove and not one that we have permits to work on, therefore not needing to stop or idle on this road. The suggested alternative, Palace Road, is not a viable option due to its narrow width and lack of capacity for two-way traffic. This includes Edith road which also leads to a dead end. The proposed changes also create a significant safety risk. Forcing all traffic onto Palace Road and Edith Road, which cannot accommodate the increased volume, heightens the risk of accidents. There are a large number of families who live here and walk to their respective schools. The routes taken mean they cross over Edith road and down

		palace road. As I have mentioned these are already very busy streets which will not be able to accommodate any large traffic flow. We urge you to reconsider the proposed extensions within the scheme to ensure that residents are given the same consideration, exempt and allowed to drive in and out of their street via Park Road. A balanced approach must be taken that works for the entire community, not just select groups. I look forward to your response on how this issue will be addressed. Best regards,

SS48	Objection	I oppose the restrictions on Park road as we have a cellar at the side of my Pub the (Springfield Tavern), the hatch for the cellar is 100ft approx from the entrance of Park Road from the junction of Bounds Green road, we need access for trucks and vans for deliveries. We also oppose the plan to replace the footway outside the Springfield tavern which would replace an existing business permit holders bay, we have a business permit, the parking outside is crucial for the business to operate, food delivery service, cash and carry, pick up and drop off for staff, entertainment and customers outside the pub, where safety is a priority.

SS48	Objection	To whom it may concern,
		I am writing to formally object to the proposed School Street scheme for 2024-T44 Bounds Green School, as it is evident that the concerns of residents have not been properly considered. The proposed changes appear to prioritise businesses over those who actually live in the area, creating serious traffic and safety concerns.
		While I fully support school zones and their goal of improving safety (my own children addent Bounds Green School), it is disappointing that feedback from residents of Park Grove and Tredegar Road has been ignored. Those living off Park Road rely on it for access, yet under the current proposal, we would be unable to drive along it. This restriction is both unreasonable and impractical, failing to account for the daily needs of residents. It is particularly frustrating that while accommodations have been made for businesses, no viable solution has been offered to those of us who live here. Whilst it also creates serious environmental and health and safety concerns.
		Residents of Tredegar Road and Park Grove still require access routes that are now heavily restricted. Park Road, designated as the school street, is crucial for entering and leaving these streets, yet we are not even permitted to park there, meaning our presence does not contribute to congestion. The suggested alternative, Palace Road, is simply not suitable due to its narrow layout and inability to handle two-way traffic. Additionally, Edith Road, which is also affected, leads to a dead end, making navigation even more problematic.
		The proposed changes also raise significant safety concerns. Forcing all traffic onto Palace Road and Edith Road will lead to increased congestion and a higher risk of accidents. These streets are already heavily used by families walking their children to school, and adding more traffic will only make them more hazardous. The safety of both residents and schoolchildren must be a priority, yet this plan overlooks the reality of how these roads function on a daily basis.
		I strongly urge you to reconsider the proposed restrictions and grant residents an exemption to drive in and out of their streets via Park Road. A fair and balanced solution must be found—one that considers the needs of all members of the community, not just selected groups.
		I look forward to your response on how this issue will be addressed.

SS48	Objection	You are including the SERVICE and Access AREA running parallel to Bounds Green Road. This stretch of land is NOT part of any Highway. The parade of shops as well as the residents living there have NO ACCESS at the back of these properties or anywhere else. The only way these can be accessed is through this SERVICE AREA. If you implement time restrictions on the access to this Service and Access area, how will the shops and the residents manage to carry on with their daily lives? What happens to goods deliveries or Repair people to come when needed. What happens if the residents need to call a cab to go to an airport or railway station during the proposed hours? How would a person with mobility impairment, who uses a cab, to come to those shops for urgently needed supplies? The shops would lose lot of customers who would refuse to come as they would not want to get penalised. It would make it very difficult to carry on normal life. This would mean a denial of our basic HUMAN RIGHTS to live and work peacefully. If you look back into the history of this piece of land, it never was under the jurisdiction of Haringey Council. It has always meant to be land for ACCESSING the shops and the residents living there as there is NO REAR ACCESS or FACILTY. This has been the case SINCE 1890 when these properties were built. The Council cannot bring this Access Area into any schemes they have for the Highway Roads. It is NOT part of any road, nor does it have any name, because it is there purely for servicing the shops and residents. Your thoughtless proposal would kill businesses there, and create job losses as well as lot of hardship for the residents. The Council cannot and should not include this piece of land, in any time restrictive schemes they plan.

The cable company and water company already made the pavement uneven and unsightly with their constant digging Can you please make Palace Road safe too and by this I mean, can there be more speed bumps in palace and can it be higher than it is. The cars also speed down this road. Can there be a speed limit of 10mph in this road as well. Thank you

SS48	Query	Queries on behalf of a constituent (who has responded to consultation independently)
SS54	Objection	I have observed the traffic at the proposed location and it's not busy enough to introduce such a change that will strongly disrupt access to Saltram Close and Sanctuary buildings (Chalkley and Mulberry House - which despite having High Road addresses are accessible for cars and deliveries only via Saltram Close; same ones you've amended on the map, as they were missing when you first asked about our opinion).
		If Haringey Council wants to make the air cleaner and life easier for the citizens, encouraging them to use public transport or commute on foot, I would strongly suggest to look at other means of access to the Welbourne Primary School and Children Centre.
		There is a walking access via an alleyway connecting High Road to Sanctuary buildings. This alleyway is used also by parents bringing children to Welbourne Primary School and Children Centre (as it is the shortest path from the bus stops W and V). I've talked to several parents that use the path and they agree that
		even though it's the most convenient way, it does not feel like a safe pathway for their children. It is uneven, barely has any light and is constantly filthy - I've seen there syringes, broken glass and piles of rubbish (please see attached some photos from different periods of time). Cleaning the alleyway up and ensuring lighting is fixed and path leveled, will definitely make life easier and 100% safer for the children and parents that pass there to access Welbourne facilities.
SS54	Objection	I would like to object, as traffic at the proposed area is already quite minimal; Saltram Close and Stainby Road are already dead end streets. This is not a busy road at all and the temporary closure is unjustified—especially given the significant disruption it would cause to access Saltram Close and the Sanctuary buildings (Chalkley and Mulberry House). Although these buildings have High Road addresses, they are only accessible by vehicles and for deliveries via Saltram Close and the road you plan to temporarily close. Residents of Mulberry and Chalkley House are not eligible for parking permits in the area, so they depend entirely on external deliveries for large or bulky items. Deliveries to these buildings are already quite compromised given the poor vehicular access route and drivers find it often difficult to

		find the address. Introducing the proposed restrictions will only make things even more difficult for the residents.
SS54	Objection	l've observed the traffic in the proposed location, and it simply isn't busy enough to justify a change that would significantly disrupt access to Saltram Close and the Sanctuary buildings (Chalkley and Mulberry House). Although these buildings have High Road addresses, vehicular and delivery access is only possible via Saltram Close — the very route that was missing from your initial map, and which you have since updated following our feedback. If Haringey Council is aiming to improve air quality and promote healthier, more sustainable modes of travel such as walking or public transport, I would urge you to consider alternative access solutions for Welbourne Primary School and Children's Centre. There is an existing pedestrian alleyway that connects the High Road with the Sanctuary buildings. Many parents use this route to take their children to Welbourne, as it's the most direct path from bus stops W and V. However, despite its convenience, it is widely regarded as unsafe — something confirmed in conversations I've had with several parents. The path is uneven, poorly lit, and frequently littered with hazardous waste — including syringes, broken glass, and piles of rubbish. I've attached photos taken at different times to illustrate the ongoing issue. Improving this alleyway by cleaning it regularly, installing proper lighting, and levelling the surface would make a real, immediate
SS54	Objection	difference — ensuring that children and parents can safely and confidently access Welbourne's facilities. This road is the only road that leads to our building. Having High Road
		address already cause us disturbance as the car/bike access is via Saltram Close and the council unjustly doesn't colllect our bins!
SS54	Support	As a local parent I strongly support this proposal. Stainby road is currently v dangerous at the start of the school day
SS54	Support	As a parent of two children at Welbourne I fully support the Stainby Road School Street. I believe it will improve safety for children on their way to and from school by reducing the number of vehicles moving past the school at peak times. My family have experienced risky manoeuvres and have almost been hit whilst on foot by drivers turning in the street after dropping children off and the proposal prevents this by removing nearly all vehicles used by parents. At the same time access rights of those with disabilities will be protected. I hope there will be an environmental benefit in the reduction of car journeys in the area and more families will have the confidence to use active travel to get to and from school as a result. My only wish is that this could be implemented sooner.

SS54	Support	I am both a member of staff at Welbourne Primary School, and a parent of a child who attends Welbourne Primary School. I have long been concerned about the way in which drivers, including regrettably other parents at the school, drive up and down Stainby Road very carelessly. We had a very near miss only this week, where another parent doing the drop-off almost struck a child while making a U-turn in the road. I am one of the parents who live a little further away from the school than many (we cycle to school/work,) but the bulk of children who attend the school live within a 5-10 minute walk from the school, and with the exception of two or three parents who have serious mobility problems, there is simply no good reason for the vast majority of pupils at the school to be brought by any means other than their own steam. Another significant issue is pollution. We have run anti-idling campaigns, and we challenge drivers who leave their engines idling outside the school when possible, but it is still a serious issue, and it seems the only way to prevent drivers from leaving their engines running is to prevent cars from accessing the school site as much as possible.
SS54	Support	In addition to the school street proposal, action needs to be taken urgently on the speeding traffic on Monument Way. There are two pedestrian crossings from the North side of Monument way across to Welbourne Primary School. Despite being a 20mph road, cars are regularly speeding in excess of 50mph in open road conditions. Several times my child has nearly been hit by a speeding car or van at the crossing, despite the green man being displayed. Many parents & carers have experienced the same driver behaviour. This could be solved with either speed humps at the crossings or revenue raising speed cameras at two points along monument way. The traffic racing East-Bound from Tottenham High Road is particularly prone to speeding as drivers find themselves with an open road after a mile of crawling traffic.
