Officers were called by [REDACTED] stating he was a performer and had been assaulted by a group of 20 Irish males whilst trying to perform at the location. Officers attended and met [REDACTED] outside. He was a performer and had been booked by an unknown Irish male to be a leprechaun as part of the St Patrick's Day celebrations. [REDACTED] states he works for

	<p>an agency and they arrange it for him. ■■■ states he arrived and before he could even take his coat off and reveal his outfit, several Irish males picked him up and started passing him around the pub. They then placed him on a table, and he did a bit of dancing in line with his performance. However shortly after he was picked up and in ■■■' words 'thrown about', until one male threw him into a wall hitting his head. ■■■ states it is not in his agreed contract to be grabbed and thrown about against his wishes and this was an assault. ■■■ stated he did not wish to progress any investigation or matter against the unknown suspect that threw him into a wall, and just wanted to record it as his agency requires it, and also as he had not been paid. Whilst on scene, the manager of the pub stated several of the group inside (it was an event with over 50 people in the pub) had agreed to pay the performer for any inconvenience and they only meant well. The manager of the pub handed ■■■ £300 without police involvement. ■■■ stated this was the end of the matter and he would not wish for any further or future action. Officers felt this was the appropriate action and a suitable result, and no further action is now required. ■■■ was given suitable medical advice as he stated his head had hit the wall, but declined LAS. He then went home.</p>
