General Actions - Provide a narrative of what happened, when, where, who was involved and why.		CAD 7605/18MAR25 NA38N, along with many other units On Tuesday 18th March 2025, police were contacted by a worker in the Hornsey Tavern Pub High Street N8, to loads of people fighting.	

	<p>Officers arrived on scene to find a very full and loud pub. Staff at the pub were spoken to who expressed that they would like all the customers to leave as they are due to shut. All customers were drunk, extremely rowdy and were difficult to move on so more units were requested to assist with lawful ejection from the premises. With more units arriving, PC ZARGARIAN-SARABI approached the group in the corner of the pub to help escort them out of the premises. Whilst asking the men politely to leave, SUSPECT who was wearing a Green top began poke/touch 1568NA on the chest. After giving multiple warnings, he reached over and touched PC ZARGARIAN-SARABI again, stating something along the lines of "YOU'LL DO NOTHING, I WILL FUCK YOU UP." PC ZARGARIAN-SARABI withdrew his BATON to defend himself as SUSPECT became increasingly aggressive. SUSPECT has then picked up his chair and made motions/advancements to PC ZARGARIAN-SARABI . SUSPECT has then started to shout at PC ZARGARIAN-SARABI stating that he is TURKISH and throughout the process of ejecting him, was shouting a variety of insults in TURKISH towards PC ZARGARIAN-SARABI. Whilst suspect was being removed from the pub by PC SMITH-SEWLOLL he has looked directly at PC ZARGARIAN-SARABI, who was behind PC SMITH-SEWLOLL and called him a 'TURKISH CUNT'. Suspect was then removed from the pub by officers, and off to the left of the pub where he was subsequently arrested for racially aggravated public order by PC SMITH-SEWLOLL. Whilst SUSPECT was being put in the cage of the van by PC SMITH-SEWLOLL he has directly looked at PC SMITH-SEWLOLL and called him a 'BLACK CUNT', where he was further arrested for racially aggravate public order. Whilst in custody SUSPECT was further arrested for Affray by PC SMITH-SEWLOLL.</p>
