Upon	

	arrival officers saw a group of males outside the pub one of whom matched the clothing description given who was detained until the informant showed a picture of the suspect. The informant stated that the group of males outside were with the suspect but he had moved on prior to police arrival. The informant stated that the altercation began when she was clearing up takeaway boxes on the table the suspect was sitting at. The suspect then began to launch between three and four glasses towards her but none of them hit her directly. The VIW has then walked to the bar where she called police via the panel alarm. The suspect has then walked towards the door to look like he was about to leave but then the suspect turns and throws the drink at her. The informant was filming and took a picture of the suspect and this has been uploaded to media manager. Statement has been obtained and a picture of the suspect is suitable for circulation
