

# 3. Comments (including reasons for objections)

In summary, support for the proposals centres on residents' desire to cut the noise and often severe vibration. Many feel that the vibration and noise is made even worse by lorries - and buses. Many residents remain concerned about speeding.

Those objecting to the proposals prefer to have humps retained because they have reduced speeding. Others question how will the proposed measures be effective. Many of those objecting generally want to keep things as they are. Some don't want the car parking spaces removed.

Object

The new proposals are absolutely infuriating. They will merely serve to return the road to its previous state as a race track. Even with the speed tables there are still a significant number of vehicles speeding. Removing the impediments to speed will just exacerbate this. On the flattest part of the road where speeding is worst the Council seems to be proposing the feeblest calming measures. Why such an unambitious and, frankly, old fashioned and ugly approach? This is a residential road. Residents are fed up of traffic being prioritised over the needs of residents and pedestrians. It is a missed opportunity for the Council to improve a road which was ruined thanks to the arrangement with TFL which resulted in the on pavement parking that has created the current racetrack and blighted the lives of pedestrians on this residential road. I would suggest that the council looks to introduce a more ambitious scheme. Remove more/all pavement parking particularly on the flat section of the road from the junction with Hornsey Lane to Landrock Road where cars increase their speed and where on pavement parking has created problems (not passable in wheelchairs etc), and a hostile situation esp for women and children. Why not introduce build outs with trees to narrow the road and improve the air quality at the same time as slowing traffic. Install speed cameras. The VAS has been demonstrated to be entirely ineffectual on this road. The traffic islands with their plastic bollards are truly just a hideous evesore. Before we had the speed tables installed there had been a serious of nasty accidents with cars ending up crossing the pavements (one very close to a bus stop). My assumption is that these new proposals will just return to that position, and it is only a matter of time before a pedestrian is injured.

Ferme Park Rd

Object

I noticed that in the initial consultation some residents were protesting about traffic calming measures due to concerns about vibrations and potential property damage. This was over a year before any actual work on the road was carried out. It is therefore suspicious, but not surprising that these claims re-emerge. I also received a premeditated printed leaflet a day after the initial installation suggesting a pre-organised protest which not empirically based. So I would like to ask if the "vibrations" and "damage" have been witnessed, evaluated and evidenced by a qualified Haringey engineer? [If there is damage, then why is Haringey rolling out harmful, damaging road schemes, are they not tested and approved before implementation? ] I would also like to state that after living here for numerous years and witnessing disturbing speeding on this road that the only thing that has actually been effective in dampening it is the existing "humps". [and even then people with work vans that are not their own, still fly over the humps ]. Roundels and polite signs, whilst lovely in essence, have absolutely NO IMPACT on people intent on speeding. I have watched when these sort of signs were on Ferme Park Road in the near past and witnessed thousands of people happily speeding past the flashing signage. Drivers who wish to speed DO NOT CARE about an illuminated LED. Sadly the proposed traffic islands, whilst they may limit overtaking, will not be seen as any impediment to the people who see a few hundred metres of straight road and put their foot down. They will simply race past the islands which will have no slowing impact at all. Speed cameras would eventually get known about and would slow some people, but not necessarily drivers who were unaware of their presence. Yes Ferme Park Road speed camera revenue alone would probably make London a fantastically rich city but would not be as effective as physical impediments to excess speed. So please, please, please keep these physical humps in place and do not remove them unless you are 100% certain they are provably detrimental to property. Humps are the only thing that has ever slowed down traffic on this road, where some get up to speeds as ridiculous as 60mph and on which people of all ages and their children cross the road between visibility reducing parked cars and people pull out of side roads into traffic coming at them at crazy, excess speeds. Keep these calming measures in place.

Ferme Park Rd	Other	My studio doesn't face the Road so I am fortunate to be untroubled by the traffic noise* per se. I cycle. The humps were improved second time round but it would be bliss for them to be removed completely. Can I encourage Haringey Council to enter into dialogue with residents before any 'improvements' are made anywhere in Borough. I cannot conceive of the costs of constantly laying down and taking up road 'improvements'.** Given the sheer force of opinion which resides along every street in Haringey, surely it's a no brainer to consult so as to save unparalleled expenditure? Working with residents; residents working with the Council. I appreciate the seriousness which LBH has undertaken this listening exercise and also the empathy with which it has acted. I sincerely hope progress is achieved in the short-term. * It was extremely apparent at the meeting that the noise really is excruciating for those who do face the road. ** Forward planning seems unexplored territory to LBH. The road was resurfaced then almost immediately taken up in parts for cabling. Then came more cabling; then the humps and yet more cabling. Can a ten year plan not be created and the deepest stuff not done first so as to prevent endlessly digging up what has only just been laid?

Ferme Park Rd	Object	From the initial consultation, some residents were complaining about vibrations and potential property damage. This was BEFORE any traffic calming measures were introduced. So, there is an irrelevant body of people who object to the "bumps". Physical impediments to speeding are in fact the only thing that will slow drivers on this road. Your proposed measures will NOT be effective, so please keep things as they are.

Ferme Park Rd	Object	I absolutely disagree with all the changes proposed to moderate the speed on Ferme Park Road. 20mph signs do not provide any enforcement of the speed limit. Some possible many car drivers will simply ignore them meaning the whole expenditure on speed calming will be waste of residents money. If car drivers are currently hitting the speed bumps too fast it shows they are not high enough to slow them. If speed bumps don't slow them, what chance do flat road markings? If you remove the speed bumps and someone is killed or badly injured because of speeding drivers, how will the council members explain this? Prior the speed bumps I have watched speeding cars daily fly down the hill often over the central line including one that flipped on its side. Please, drivers simply have to get used to going slower, and signs will not enforce the behaviour change. The proposals simply reverse all the measures, meaning the whole initiative will be a waste of our money. This should not be allowed to happen, and I will seek to find if legal measures can be taken to review council decision making if the revised scheme goes ahead.
Ferme Park Rd	Other	I am surprised to see that the road bump around the bottom of Ferme Park Road (next to the junction with Weston Park) is not being removed alongside the other 6 road bumps. It is evident the council has found that the road bumps are causing damage to properties as well as noise issues to residents but has decided to leave some road bumps in place, prioritising some people's well-being and properties over others. It is also clear, by the fact that a proposal is being made for a flat (without road bumps) zebra crossing further up Ferme Park Road that this offers a safe option and could have been applied to my he zebra crossing near the junction to Western Park. Local government decision making should be evidence based, consistent and equitable to all residents. This decision appears to be none of those things. This is the first we've heard of any of these changes as we've not previously received letters.
Ferme Park Rd	Object	While I support speed restrictions, I don't believe they should result in the loss of parking spaces. I have 2 small children and carrying them alone, uphill and a far distance to the car gives me EXTREME anxiety. You have already removed 2 parking spaces outside our house to build an island, which has been ineffective at reducing car speed. So proposing to spend more money to build another ineffective island and remove 12 (!!) parking spaces does not seem like a logical idea. As suggested in our last speed reduction objection, which was ignored, there are other alternative measures that could be implemented if you truly want to reduce speed. E.g. speed camera. Clearly the speed tables and islands have been ineffective, so to install more would be a complete waste of money and time.
Ferme Park Rd	Object	The proposal will do nothing to reduce speeds. Need average speed camera at each end and top of the hill. Initial revenue in thousands of £. The excuse of TFL which has been used for 10+ years is unacceptable. Needs to change. Bureaucracy is supposed to represent the people and over 50% of previous consultation responses asked for camera enforcement.

		measures are far from sufficient. Dangerous speeding is a massive issue even
		with the present speed tables, and their removal would make the situation
		much worse. We have also had a lot of disruption in the W3 bus service
		recently - we really don't need another lengthy disruption.
Ferme Park Rd	Object	Ferme Park Road remains an incredibly dangerous road. The raised speeds
		tables have proved ineffective, and cars still race up and down the road at
		terrifying speeds. I've seen many cars overtaking other cars on the wrong side
		of traffic islands too. The most dangerous section is the junction between
		Ferme Park Road, Stapleton Hall Road and Florence Road, and these
		proposals do nothing to mitigate those risks - I have seen evidence of
		numerous accidents at this junction over the years, and it's only a matter of
		time before there is a loss of life or serious injury. Please reconsider these
		proposals to slow traffic down at this junction as well.

		the current measures can remain in place.

		but taller speed bumps, such as on Shepherds Hill? Buses use that route and

Object	I object to proposals #1 and #6 to install 2 additional traffic islands for the
	following reasons:- a) Haringey Council has announced that £200K funding
	has been allocated to install traffic lights at the junction of Tottenham
	Lane/Ferme Park Road. There is no mention of this in the consultation and
	there is no assessment of the speed reduction impact of installing traffic lights.
	There is therefore no need to have a traffic island at the junction of Fairfield
	Road so close to the proposed traffic lights. b) The proposal to have 2
	additional traffic islands (proposal #1 and 6) would mean a total of 5 traffic
	islands which is unreasonable given the size of the road and other calming
	measures. c)The loss of a further 20 parking spaces is unreasonable
	considering the number of parking spaces already lost due to previous
	calming measures. d)The experience from the 3 traffic islands already in place
	is that buses find them hard to negotiate and thereby cause additional noise
	and vibrations. Adding 2 further traffic islands would only make this worse.
	e)I believe that instead of installing 2 further traffic islands it would be better to
	have simpler low cost measures which would be equally effective such as

	Object	We vehemently disagree with the proposed speed reduction measures. We have no issue with the current speed tables; whilst we agree the traffic moves
Ferme Park Rd	Other	faster than it should, the speed tables seem to be the best option. If the vibrations of traffic are negatively affecting the neighbours quality of life, we understand the consultation for their removal. However, we completely reject the proposed replacement plans. The traffic island installation outside our house would encourage a pedestrian crossing area in the road, increasing footfall outside our home. The removal of the car parking spaces is unacceptable. I am contracted to drive for work and frequently have to transport lots of items which I need to carry to and from our house. The removal of the parking spaces would negatively affect my daily life as I need to be able to park nearby to load and unload my car for work - the current road layout with proximity of parking to our home was a primary reason for moving here. The cars parked directly outside our house actually create a shield between the traffic and a relatively narrow pavement, the removal of this would bring the traffic closer to our front door directly and would expose us to moving traffic whilst walking on the pavement. The parked cars mean our homes are stepped back from the traffic; moving us closer will make us feel like we're living on a main road or high street and could potentially be a reason to devalue the home in time. As we have had no issue with the speed tables, we take umbrage by the proposed compromises to our daily life. The current parking arrangement works for us and our neighbours, and we pay the council to park here. Taking away the parking spaces and drastically changing the road layout through months of disruption by doing works on the road is unacceptable. We will have to endure the stress of road works, the noise, limited access to our road whilst this goes on, and to have our home newly exposed to the traffic where it's brought closer to the pavement, and the loss of parking that I need and pay for is something we cannot accept. We absolutely reject the changes to the area outside 64/66 and will petition the proposed c

Ferme Park Rd	Support	Speed tables outside 256 Ferme Park Road must be removed immediately. Their design and placement are entirely unsuitable for this location. Since installation nearly a year ago, the speed table has caused severe vibrations to my home, leading to sleep deprivation for my family, a condition now medically documented by the NHS. Ferme Park Road carries high volumes of heavy traffic, including buses and lorries with unladen weights of up to 18 tonnes. These vehicles cause intolerable shaking, posing an ongoing risk to our physical and mental well-being. This is not a minor nuisance or hypothetical concern - it is a daily health hazard. Therefore, no future schemes at or near 256 Ferme Park Road must include vertical traffic calming measures of any kind.

The Council has admitted a reason for removal if the bumps and tables is their causing structural damage. These claims should be prompt and fully dealt with asap. 4. The roundabout was damaged by a bus failure - not the road layout in September 2021. The existence of the roundabout likely slowed the bus with failed breaks and reduced damage and injury. As part of the works the Council should rectify damage that would have been covered by insurance- it's almost 4 years. Again this work should consider greening the area and adding planting to the roundabout. Local residents have indicated that they would be willing to support maintenance of planted areas such as this.

Mount View Rd	Object	It seems scarcely believable that Haringey Council, which is in a precarious financial position, could have gone ahead with an extensive and expensive speed reduction programme on Ferme Park Road - and then roughly 12 months later scrap most of the measures after 'feedback' about noise, vibration and structural damage. Why did the council not follow through on these concerns before they gave the green light to the scheme? Council officers will be well aware, based on the evidence of the Clissold Park section of Green Lanes, that the only effective strategy to counteract speeding traffic on a through route is speed cameras. Roundels, pedestrian crossings, electric messages with smiley faces simply do not cut through with those drivers determined to use the road as a racetrack. I am well aware that TfL is responsible for camera installation. If Haringey is serious about making Ferme Park Road a safe road for law-abiding motorists, cyclists and pedestrians it surely needs to have a dialogue with TfL. Failure to do so puts residents safety at risk

Landrock Rd	Other	We live in Landrock Road, in the terrace which runs from the junction with Ferme Park Road as far as Gladwell Road. 1. We have a strong interest in
		this consultation for the following reasons: 1.1 We contacted the Council in October 2011 about heavy vehicles coming at speed down the hill and hitting
		the uneven areas in the road around our junction- particularly exacerbated by dips around the surface of the road around the Thames Water service covers.
		On inspection the Council noted a "Defective Carriageway" and that vehicles travelling downhill would "bounce". They referred the matter to Thames Water.
		1.2 Once Thames Water had done remedial works the situation improved significantly but it deteriorated again over time. There have been further works
		in subsequent years. In January 2020 we again reported a "pothole" on Ferme Park Road to the Council, and this was again referred to Thames Water. 1.3
		By 2023/2024, before the roadworks and introductions of speeding restrictions we were again concerned about heavy vehicles like the regular W3 buses and
		lorries hurtling down the hill and hitting the uneven road surface at our junction, and there were again issues of dips around the service covers. 2.
		Our experience since 2024 2.1 The situation has improved significantly for us since the introduction of speeding restrictions and the works to the road at the
		junction. 2.2 We feel much safer crossing the road thanks to the introduction of the wider traffic island with pedestrian refuge which is opposite 130/132
		Ferme Park Road. Thanks for this. 2.3 This island appears to be effective in slowing down larger vehicles as they negotiate the narrowing of the
		carriageway. 3. Our comments on the proposed amendments to the speeding restrictions 3.1 We support revised restrictions to address the
		concerns of residents about vibration and noise caused by the speed bumps and, crucially, to maintain safety. We have two main concerns which we hope
		you can address: 3.1.1 The road near our junction still seems uneven, and this is particularly obvious if you watch the movement of the W3 buses
		heading downhill as they cross the speed table and pass the junction, so we would be glad of regular monitoring of this jointly by the Council and Thames
		Water. 3.1.2 How can you ensure that the 20mph speed limit is observed along the whole of the road? We are particularly concerned about the traffic
		heading down the hill from the top of Ferme Park Road, past Dashwood Road towards Landrock Road, where the temptation is for drivers to pick up speed.
		The "slow" road markings currently on the hill are already looking faded; regularly refreshing with paint might help, but would it be feasible to install an
		additional measures such as an extra Vehicle Activated Sign around this point too? Thanks to everyone who is working to find the best possible outcome.

Weston park primary school, St Gildas, St Peter's, St Aidens, and Hornsey school for girls are all very close and many pupils need to cross Ferme park road in order to get to school. The union church, and St Peter's church also contribute to the footfall - with many attendees being elderly etc. I would support the addition of islands close to the current speed bumps, to force drivers to slow down for the speed bumps. But I don't think the islands alone will act as a massive speeding deterrent. (The pedestrian crossings don't even act as a massive speeding deterrent). I don't think the illuminative signs make much difference as people just ignore them. I think the only thing other than speed bumps which makes a difference is speed cameras. But I know this is probably not something the council can add to minor main roads like Ferne park.
