PROPOSED SPEED REDUCTION SCHEME – PERTH ROAD N22 The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No.***) Order 202*

Notice is hereby given that the Council of the London Borough of Haringey proposes to make the above mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended and under section 90a and 90c of the Highways Act 1980 and the Highways (Road Humps) Regulations 1999 to introduce speed humps at the locations detailed below.

The general effect of the Orders would be:-

1. As part of the speed reduction measures, the footway will be built out and extended into the carriageway for a maximum distance of approximately 2 metres outside No.36 and No.38 Perth Road N22. The existing double yellow lines will be adjusted in accordance with the new kerb line while it is also proposed to introduce double kerb blips (no loading at any time) at this location as detailed below:
 - a. On Perth Road N22 outside No.36 for 9 metres from the junction with Paisley Road
 - b. On Perth Road N22 outside No.38 for 6.7 metres from the junction with Paisley Road
 - c. On Paisley Road N22 both sides from the junction with Perth Road for 7 metres.
2. Speed humps (flat-top road humps) will also be introduced on **Perth Road N22** with the centre of the humps at the following approximate locations (each with a total length of 10 metres inclusive of ramps and a maximum height of 100mm):
 - 1) Outside No.23 Perth Road N22
 - 2) Outside the shared boundary of No.35/37 Perth Road N22
 - 3) Outside No.49 Perth Road N22
 - 4) Outside the shared boundary of No.61/63 Perth Road N22
 - 5) Outside the shared boundary of No.75/77 Perth Road N22
 - 6) Outside the shared boundary of No.87/89 Perth Road N22
 - 7) Outside the shared boundary of No.109/111 Perth Road N22
 - 8) Outside No.117 Perth Road N22
