Possibly		The consultation process that has underpinned this project has been extensive. It has been based not only on a co-production approach but also trialling a participatory budgeting approach. Consultation & engagement has been undertaken for each of the 5 sites, online via Commonplace, inperson at each park, in-person at schools local to each site, via target groups representing people with disabilities and women and girls groups, as well as with each park's friends group and ward councillors. At one of the sites there is a large Jewish community, and additional consultation has been undertaken to ensure that the voices of this community are heard and taken into account. It is anticipated that impacts would be either positive or neutral. However, as a pilot project, with regard to the participatory budgeting approach, the more detailed analysis of an equality impact assessment would be beneficial.
