Dear Sirs,

I was deeply distressed to see a notice in my local pub this evening, when I popped in for a bite to eat.

The Vicotria Stakes, is not just one of the best in the borough—it is the heart of our community. I find it almost impossible to believe that anyone could make a complaint against such a well-run, welcoming, and responsible establishment. I have been a regular there since I moved to the area 18 years ago, and in all that time I have never once witnessed antisocial behaviour, seen children put at risk, or observed anything that would justify putting its licence in jeopardy.

Over the years, this pub has been the setting for so many important moments in my life and the lives of others in the community. I have attended weddings there, enjoyed comedy nights, shared Christmas lunches, and celebrated countless milestones. Most memorably, I even managed to celebrate my 60th birthday there—legally and responsibly—during lockdown with a small group of friends.

We live in a very neighbourly community, and this pub is central to how we connect—particularly through its hugely popular quiz nights. For many of our young people, it has been their very first place of employment, helping them take their first steps into working life.

We are losing pubs at a devastating rate—around one every day—and with each closure we lose a piece of our social fabric and local heritage. While I understand that action must sometimes be taken against establishments where genuine issues exist, for example the N8 (formerly the Hornsey Tavern) this pub is a highly respectable venue and bears no resemblance to those that warrant such scrutiny.

If someone chooses to live near a pub, they must surely accept that there may be inconveniences. It seems unreasonable to expect a long-standing, much-loved community institution to be threatened as a result.

As a woman, I have always felt completely comfortable and safe going there alone, which is something that cannot be said for every public space. That sense of safety, inclusivity, and belonging is invaluable and rare.

We cannot afford to lose this pub. I urge you, with absolute sincerity, not to revoke its licence. Doing so would not only be unjustified—it would be heartbreaking.

It has been brought to my attention that there is a licensing review of the Victoria Stakes. This has raised some serious concerns as the Stakes is our local pub and a key part of our community and particularly a good meeting place for friends, neighbours and family.

We live on XXXXXXXXXXXX Road and the Victoria stakes is our local pub, which is a very relaxed place to visit, meet, have a drink and often eat food. It is part of the reason why we moved here in 2020 as it is a 2 minute walk for us and has proved to be exactly what a local pub should be.

The Stakes is a brilliant local pub, with the majority of clients being older people, 30+ with the majority being 40 - 60. It caters perfectly for those of us that do not want to be in a noisy pub with loud music. The choice of drinks are vast and varied (not generic), the food is excellent and the pub is definitely aimed at a more established local client.

I am struggling to see why there is a licensing review on this pub considering that:

1. I have never seen or experienced any signs of disorder or unruly behaviour, either in the pub, or around the pub at any time,

Hello,

I am writing to make a formal representation in support of the Victoria Stakes public house in relation to the current review of its premises licence, specifically regarding the allegation that it has failed to uphold the licensing objective of the prevention of public nuisance.

I have lived in the vicinity of the Victoria Stakes for over 20 years, and my wife has lived locally for over 30 years. During that time, the pub has been a long-standing and valued part of the local community. Based on our extensive experience living nearby, I do not recognise the characterisation of the premises as a persistent or unreasonable source of public nuisance. I regularly frequent and pass by the pub at various times of the day, evening, and late night, and I see no evidence that would justify a review in respect of public nuisance.

In our experience, noise levels associated with the Victoria Stakes are entirely consistent with what one would reasonably expect from a well-run public house, particularly one located in a mixed residential and commercial area of London. Any occasional noise from patrons or music should be viewed in the wider context of urban living, especially given that the premises is situated at one of the busiest road junctions in Haringey, where background traffic and general city noise are a constant feature.

Importantly, the pub has historically demonstrated a responsible approach to its operation, including the management of customer behaviour and adherence to appropriate closing times. Over many years of residence, we have not experienced sustained or excessive disturbance that would support the conclusion that the licensing objectives are being undermined as part of the premises' day-to-day operation.

I am concerned that the complaint prompting this review may reflect an isolated or subjective experience rather than a pattern of behaviour or a systemic failure by the premises. In my view, it would be disproportionate to penalise a well-established local venue, one that has coexisted with nearby residents for decades, on the basis

of a single or limited complaint, in the absence of clear evidence of persistent nuisance or failure to engage constructively with residents.

The Victoria Stakes contributes positively to the local area both socially and economically and plays an important role in community life. I respectfully urge the Committee to give due weight to the views of long-term residents such as myself, whose lived experience suggests that the premises has operated responsibly and in a manner consistent with the licensing objectives.

For these reasons, I ask that the review be approached with proportionality and balance, and that the premises licence be allowed to continue without unnecessary restriction.

We understand that the Victoria Stakes, 1 Muswell Hill, N10 3TH is subject to a Review under the Licensing Act 2003. We wish our experience and views to be considered as part of this review.

We have lived close to the Victoria Stakes for over thirty years and have frequented it quite often over that period. In all that time, we have never experienced any public nuisance, disorderly or criminal conduct, or any safety concerns associated with the premises. Though it has changed ownership in recent times, we have not noticed any difference in terms of customer behaviour or management oversight.

The pub's clientele is well-behaved and compliant with rules. In fact, the pub attracts an older, more mature age group who express themselves with less exuberance than the younger clientele of many other pubs locally, which creates a calm, and frankly, rather staid atmosphere. In our experience, it is never loud and boisterous.

We don't object in the least to events at Alexandra Palace, but it should be noted that these create most of the noise, traffic congestion and crowd issues in this locality; the Victoria Stakes is insignificant in comparison.

It is a positive feature of the locality, providing a convenient and accessible space for nearby residents. For the many elderly people who live in the vicinity there is nowhere else for them to meet, eat and socialise in congenial surroundings within walking distance (other pubs and cafes either cater for a different demographic or don't open in the evenings). Most importantly, it has been generous in providing support and facilities for several voluntary community groups.

We should state that we have no financial or other interest in the Victoria Stakes; we don't know the owners or the complainants, and we are writing to you solely in the interests of preserving a valued community facility and resource.

We have no knowledge of the specific complaints that have given rise to this licensing review, but from our experience, we can only assume they are vexatious and should be dismissed.

I cannot begin to imagine a problem with the Victoria Stakes, they have no regular live music, it is a completely different class of pub, that is reflected in the clientele.

The problem with pubs today I would suggest that since the smoking ban virtually all licensed premises have people outside.

Go to any pub with a bar full of say just 50 people, talking, laughing and you will experience a certain volume of noise.

Should we refuse licenses for every premises across the town due to one or two complainants?

As local pubs struggle with costs, I feel we and our councils should support local community hubs before we have none left, and no community.

My name is Thomas Galster and I lived at XXXXXXXXXXXX from early June 2025 until late September 2025, during which time I was applying for part-time work, attending interviews, and preparing for university exams.

During this period, loud amplified music and large outdoor events at the Victoria Stakes regularly disrupted my ability to study at home. On several occasions I had to leave the house to prepare for exams because the noise from the rear yard was too intrusive to work through. I experienced similar disruption when completing job applications and interview preparation.

Family meals and quiet evenings were frequently affected when events were taking place. I often felt unable to relax in my own home and sometimes left purely because the noise became too loud and overwhelming. Social time with friends was also cut short or abandoned due to the disturbance. It genuinely felt like we were being pushed out of our living space.

Even now, when I return home from university, I find it difficult to know whether I will be able to rest or work due to the unpredictable level of music and crowd noise from the pub. This uncertainty has made me reluctant to come home, as I cannot predict what level of disruption I am returning to.

I hope this representation is helpful to your review. I am no longer living permanently at XXXXXXXXXX, but my experience from June to September 2025 was consistently affected by noise from the premises, which I believe clearly engages the licensing objective of Prevention of Public Nuisance.

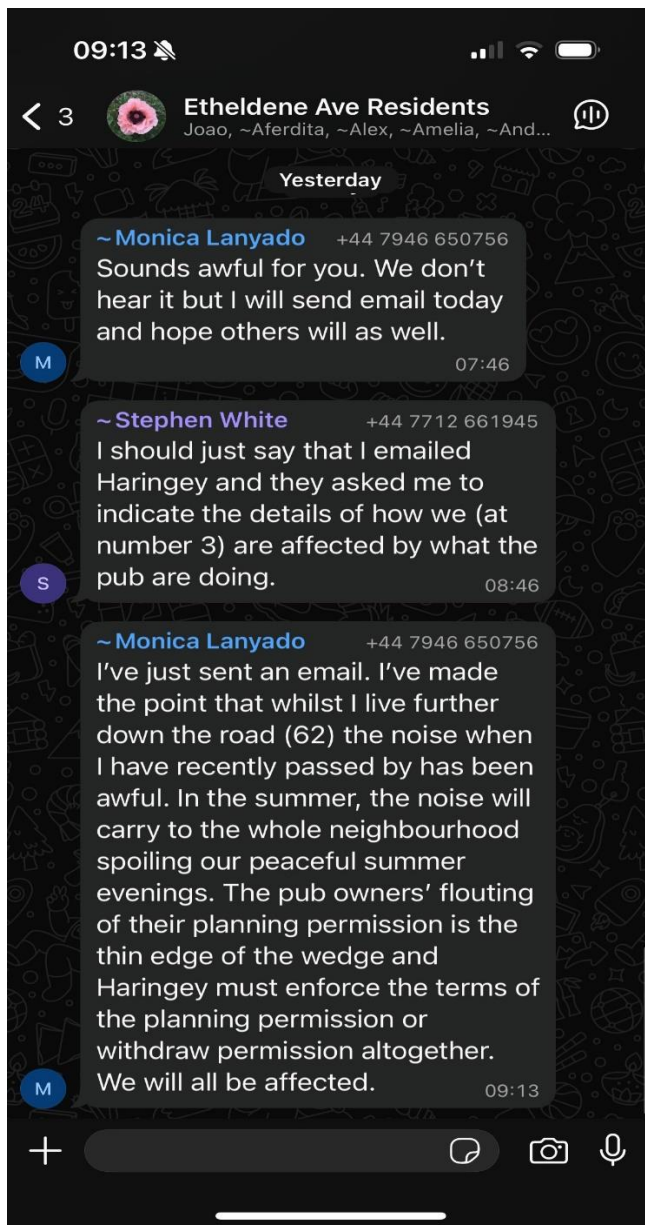

I live 240m from the Victoria Stakes -- it is my local pub, and as well as frequenting it for a drink, we have used it for family events. It is a valuable and much loved local resource.

The sign says that they have failed to uphold the licensing objectives of

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

As a local resident with children, who both visits and walks past the Victoria Stakes very frequently, I have never observed anything that could be classed as them failing to prevent crime and disorder, problems with public safety, or the protection of children from harm.

I've heard some neighbours are complaining about noise nuisance. I have personally never encountered unwanted noise from the Victoria Stakes, and indeed when using the back 'covered' area as part of a large group, have been advised by staff that we should avoid being too noisy. Last time we booked an event there (which was under the previous management), our contract stated: "The Yard is background music only. The Dining Room can be used for dancing, bands & DJ's with the back door being kept closed at all times. All PA's, DJs, Bands are subject to sound limiter and governed by the Duty Manager onsite."

Not wishing to appear legalistic but I note that the much venerated Lord Denning said this:
 "a public nuisance is a nuisance which is so widespread in its range or so indiscriminate in its effect that it would not be reasonable to expect one person to take proceedings on his own responsibility to put a stop to it, but that it should be taken on the responsibility of the community at large."
 It is hard to believe that anything that is alleged to have happened at the Victoria Stakes comes close to meeting this definition. On the contrary, it is the kind of place that has a wide local following and attracts universal applause and affection.
