The premises will operate with well-trained staff who understand their responsibilities under the Licensing Act 2003. A trained and responsible DPS or personal licence holder will be present or contactable at all times alcohol is sold. Clear policies will be in place covering age verification, incident management, refusal of sales, and dealing with disorder. CCTV, staff vigilance, and strong management procedures will be used to ensure the premises operate safely and responsibly at all times, including late at night. The premises will cooperate fully with the Police, Licensing Authority and other responsible authorities.

b) The prevention of crime and disorder

A high-quality CCTV system will be in operation inside and outside the premises, recording 24 hours a day, with footage retained for a minimum of 31 days and made available to Police upon request. Staff will be trained to recognise and refuse service to anyone who is intoxicated or behaving in a disorderly manner. A refusals log and incident log will be kept and updated after each relevant incident. The premises will maintain good lighting at the entrance and around the shopfront to deter crime and anti-social behaviour. Alcohol will be stored behind the counter or in monitored areas to reduce theft.

c) Public safety

All aisles and exits will be kept clear and unobstructed at all times. Staff will be trained in emergency procedures, including evacuation and fire-safety measures. Any defective equipment, lighting, or hazards will be identified and repaired promptly. Safety signage and good lighting will be maintained throughout the premises, especially during late hours. The shop will operate with an appropriate number of staff during late-night hours to ensure safe supervision.

d) The prevention of public nuisance

No music or loud noise will be played that can be heard outside the premises. The area immediately outside the shop will be kept tidy, with regular checks to remove litter. Staff will monitor the front of the premises to prevent groups from gathering or creating noise during late-night hours.

e) The protection of children from harm

A strict Challenge 25 age-verification policy will be enforced. Staff will receive regular training on underage sales, fake IDs, and age-restricted products. A refusals register will be maintained and reviewed regularly by management. All alcohol will be displayed in clearly supervised areas of the store. Children will not be allowed to purchase any age-restricted products, and where necessary, staff will remind unaccompanied young persons of the law and act responsibly.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
