My objection is based on the clear risk that granting this licence will undermine the following Licensing Act 2003 objectives:

- Prevention of Crime and Disorder
- Prevention of Public Nuisance
- Protection of Children from Harm

1. Existing Anti-Social Behaviour in the area

Tottenham High Road and the immediate surrounding areas already suffer from extensive anti-social behaviour including

- Public drinking
- Groups loitering around local shops
- Loud disturbances and disorderly conduct
- Intimidating behaviour towards residents
- Littering, broken bottles and general street nuisance
- Occasional acts of vandal and property damage

Residents have repeatedly raised concerns about safety and the impact this has on community wellbeing.

2. Community Crime-Fighting Efforts highlights the severity of the local issues.

The fact that a Community Crime-Fighting meeting was held in Haringey on 27/11/25 demonstrates that crime and anti-social behaviour in this area are already of significant concerns to the residents, community groups and local authorities.

I am writing to formally object to the application for an alcohol licence 07:00 to 02:00 for Trinerta Foods Ltd, Tottenham post office, 824-828 High Road, Tottenham N17 0EZ.

My objections are based on the clear risks that granting this licence will undermine the following Licensing Act 2003 objectives:

1. Prevention of Crime and Disorder
2. Prevention of Public Nuisance
3. Protection of Children from Harm

Existing crime and Anti-Social Behaviour in the area -

Tottenham High Road and the immediate surrounding areas including Roebuck Close, Bennett's Close, and Cooperage Close already suffer from extensive anti-social behaviour including Public drinking of alcohol in large Groups. These groups loiter around the local shops including the applicants premises and the entrance to Roebuck Close leading from the High Road.

The groups cause Loud disturbances on a daily basis consuming alcohol purchased from nearby shops, playing music and even lighting BBQ's on the public road. The amount of litter including uneaten food and broken bottles left behind is disgusting and a clear safety issue. Fights regularly breakout with one male being stabbed and a female receiving GBH head injuries at these gatherings this year.

Residents have repeatedly raised concerns to the police and council about intimidation and safety, and the impact this has on community wellbeing. The area is no go area for residents after dark.

An additional alcohol licence on Tottenham High Road will likely:

Increase street drinking and Lead to more instances of crime and Anti social behaviour in the area. This will Place additional strain on overstretched police and community safety resources.

Local police, council and residents meetings have already highlighted this area as requiring intervention; adding another alcohol outlet would worsen an already fragile situation.

Public Nuisance to Local Residents -

The constant noise, disturbances, and general nuisance are significant issues within the area, particularly in the evenings and weekends. Granting a new licence allowing alcohol sales at this premises will increase the footfall and heighten the risk of further disturbances outside the shops and within nearby estate areas.

Impact on children and young people -

Children walking to and from school, youth clubs, and local events already encounter groups consuming drugs and alcohol in this area. They are subjected to drug and alcohol related crime and Anti social behaviour on a daily basis.

Granting this licence will further increase the risk of Children witnessing this behaviour or becoming victims of crime.

This application does not provide adequate measures to prevent alcohol sales from contributing to Anti social behaviour, crime, and disorder in the area. There is no robust plan for staffing, security or preventing on-street consumption.

For all the reasons above and given the active steps being taken by the community to reduce crime and anti-social behaviour, I strongly urge the Licence Committee to refuse the alcohol licence application for Trinetra Foods Ltd, Tottenham post office, 824-828 High Road, Tottenham N17 0EZ.



Subject: Representation Against Licence Variation – Tottenham Post Office, 824-828 High Road, N17 0EZ

To the Licensing Team,

I am writing to object to the proposed variation of the premises licence for **Tottenham Post Office** to allow the supply of alcohol **and opening hours until 2 AM daily**.

1. Prevention of Crime and Disorder

Tottenham already experiences significant issues with anti-social behaviour, alcohol-related disturbances and drug misuse, particularly late at night. Extending retail alcohol availability until 2 AM is likely to *increase public disorder*, street drinking and intoxication in an area that is already struggling with these issues, rather than reduce them. The Metropolitan Police have previously objected to late night licences in

Tottenham, citing a risk of greater crime and disorder if hours are extended in this borough area (<https://haringeycommunitypress.co.uk/2025/11/05/police-object-to-tottenham-shisha-lounges-bid-to-sell-alcohol-until-2am>).

2. Public Safety Concerns

Late-night alcohol sales can lead to intoxicated people on the public highway late into the early hours, creating safety risks for pedestrians and residents returning to homes. Tottenham High Road is busy, and increased footfall with alcohol consumption late into the night could exacerbate road safety and nuisance issues.

3. Public Nuisance

Noise, shouting, congregation and litter from customers leaving premises late at night are well-documented nuisances associated with extended alcohol licence hours. In other licensing cases in Haringey, noise and nuisance officers have raised objections to late licences because of loud music and disturbance to nearby residents (<https://opencouncil.network/meetings/70362>). Giving a convenience store licence to sell alcohol until 2 AM is likely to contribute to *late night noise disturbance, shouting, and public disorder in a residential neighbourhood*.

4. Impact on Local Community Well-Being

Tottenham High Road and the Northumberland Park area already have high levels of socio-economic disadvantage. Extended drinking hours could worsen problems with late-night street drinking and discourage families from feeling safe in their own community. These social harms outweigh any commercial benefit of extending licence hours.

5. Lack of Clear Justification for Extended Hours

The application does not include detailed proposals on how the premises would responsibly manage alcohol sales and mitigate risks of crime, disorder, and nuisance; this lack of information undermines confidence that licensing objectives will be upheld.

For the above reasons, I respectfully request that **the licence variation to allow alcohol sales and opening hours until 2 AM be refused or significantly restricted** in line with the Licensing Act 2003 objectives to prevent crime and disorder, protect public safety, and prevent public nuisance.

To Whom It May Concern,

Re: Objection to Licence Variation – Tottenham Post Office, 824–828 High Road, N17 0EZ

I write to formally object to the proposed licence variation for the above premises. This representation is made under the Licensing Act 2003 and is based on concerns that the application undermines multiple licensing objectives, particularly in an area already experiencing high levels of crime and anti-social behaviour.

Licensing Objectives

Under Section 4 of the Licensing Act 2003, the Licensing Authority must promote the following four objectives:

The Prevention of Crime and Disorder

Public Safety

The Prevention of Public Nuisance

The Protection of Children from Harm

This objection is made primarily on grounds that the proposed variation would negatively impact objectives (1), (2), and (3).

Grounds for Objection

1. Prevention of Crime and Disorder

Tottenham High Road is a location with well-documented and persistently high crime levels, including violent crime, drug-related offences, public order incidents and anti-social behaviour (ASB). Local crime data shows that ASB incidents alone are recorded at a high monthly rate in the immediate vicinity.

The introduction or expansion of licensable activities—particularly those involving alcohol—creates a real risk of increasing crime and disorder, including:

Street drinking and congregation outside the premises

Increased risk of confrontations, disorder, and public order offences

Greater likelihood of theft, drug activity, and harassment in the surrounding area

Given the existing crime profile of the area, any variation that increases availability, hours, or intensity of licensable activities is likely to exacerbate existing problems, contrary to the crime prevention objective.

2. Public Safety

The High Road is a busy, high-footfall environment with significant pedestrian movement, public transport usage, and nearby residential accommodation. Public safety concerns arise from:

Increased intoxication levels in an already pressured public space

Risks of disorder spilling into the street, bus stops, and neighbouring shops

Pressure on emergency services and policing resources

In an area already experiencing above-average levels of violent and public order crime, the proposed licence variation poses a foreseeable risk to public safety, particularly during evening and late-night periods.

3. Prevention of Public Nuisance

Residents and businesses along Tottenham High Road already experience significant disturbance linked to ASB. The licence variation risks increasing:

Noise from customers congregating outside the premises

Littering, public urination, and other street-level nuisance

Loitering and intimidation, particularly during extended hours

These impacts would undermine local amenity and quality of life and are inconsistent with the Licensing Authority's duty to prevent public nuisance.

4. Protection of Children from Harm

The premises is located in an area used by families and young people, with schools, transport hubs, and youth facilities nearby. Increased alcohol availability raises concerns about:

Exposure of children to intoxicated behaviour

Increased risk of proxy purchasing

Normalisation of street drinking and disorder in a public shopping environment

While this may not be the primary ground of objection, it remains a relevant consideration under the Licensing Act.

The Tottenham High Road corridor already accommodates a high concentration of commercial premises and experiences cumulative pressures associated with crime, ASB, and public nuisance. Granting a licence variation in this context would add to these pressures and conflict with the licensing objectives.

For the reasons outlined above, the proposed licence variation fails to adequately promote the licensing objectives, particularly the prevention of crime and disorder, public safety, and the prevention of public nuisance.

I therefore respectfully request that the Licensing Authority refuse the application, or in the alternative, impose strict conditions sufficient to mitigate the serious risks identified.
