I fully recognise the importance of disabled parking provision, and I am aware of the relevant legislation and responsibilities under the Equality Act 2010 and Haringey Council's own parking policies. However, I would like to highlight that there are already three disabled parking bays on the same road, none of which are being utilised regularly by neighbours with blue badges. These bays often remain empty, as most residents understandably prefer to park directly outside their own homes, regardless of whether they hold a disabled badge.</p> <p>This situation has created a real imbalance. Non-badge holders are effectively excluded from using these spaces, and as a result, many residents are forced to park on pavements or they receive a ticket. This is not fair and causing an obstruction.</p> <p>I am increasingly worried about the impact of the new development in the area. Once the new build comes into play, the pressure on parking will only intensify. We are already seeing cars from neighbouring roads using Kerswell Close as overspill parking, and this will inevitably worsen. The current arrangement feels unfair and unsustainable, as it prioritises spaces that are left unused while residents without blue badges have no reasonable options.</p> <p>I kindly request that the Council reviews the designation of the disabled bay at 32 Kerswell Close in light of these circumstances. A more balanced approach to parking provision is urgently needed, particularly to ensure fairness for all residents while still meeting the needs of disabled drivers.</p> <p>In addition to the above, I would also like to raise concern regarding a neighbour who has left a vehicle parked in the area for over eight weeks without moving it.
