Why do we need a Pharmaceutical Needs Assessment?



- The government has asked all Primary Care Trusts to put a Pharmaceutical Needs Assessment in place by February 2011
- Assesses needs of people living within Haringey.
- Assesses how pharmaceutical services (e.g. dispensing of medicines, advice on management of minor illness, review of medicines use) are meeting that need or could meet that need
- Highlight whether there are gaps in the pharmaceutical services and how the gaps may be addressed.

What's in the Pharmaceutical Needs Assessment?




- A complete picture of current community pharmacy and dispensing services in Haringey
- Local Health Needs
- Access and Services (mapping need against provision)
- Patient Experience (from questionnaire)
- Essential Services (e.g. dispensing, health promotion)
- National Advanced Services Medicines Use Review
- Local Enhanced Services (e.g. smoking cessation/Minor Ailments Scheme)


