What is a Controlled Parking Zone (CPZ)?

A Controlled Parking Zone (CPZ) is an area where all on-street parking is controlled either by yellow lines or designated parking bays.

CPZs ease congestion caused by illegal and obstructive parking by introducing waiting restrictions where parking is undesired.

CPZs give priority to residents and local businesses, and their visitors, who must display permits or vouchers to show their entitlement to park.

CPZs are usually located in town centres and areas surrounding underground and rail stations where parking pressure most affects local residents. Some roads further away from stations are included in the Zone to prevent displaced motorists from parking in these roads.

Outside the hours of operation parking remains unrestricted, unless otherwise stated.

Double yellow lines prohibit parking at any time regardless of the CPZ.

A permit for one CPZ does not allow the holder to park in any other CPZ.

How do CPZs work?

CPZs work by ensuring that vehicles park in designated bays at certain times of the day. Outside of the operating hours of the CPZ, the parking bays do not apply and parking is unrestricted, except where yellow lines operate for longer periods.

CPZs operate at different times of the day depending on the parking demand, with each zone designed to deal with specific problem in the area.

Different types of bays are provided for specific groups of motorists. In this instance, there are three main types of bay provided:

- Residential – for residents of the roads in the area and their visitors
- Business – for businesses that require a vehicle for business use
- Pay and display parking bays – short stay for visitors and shoppers

Any vehicles that are parked illegally are liable to receive a parking ticket, issued by uniformed parking attendants who would regularly patrol the area.

Operating hours of the CPZ

Short periods (e.g. two hours) are often used around rail and tube stations to prevent commuters parking all day. Outside these hours anyone can park freely without restriction. This provides limited protection against non-commuter parking but does offer greater flexibility for visitors, carers, and those coming to the area to shop. A 2-hour CPZ operates in Highgate Station CPZ.

All day controls are effective in areas where there is a high level of parking during the day because of factors such as proximity to commercial centres and rail/tube stations. All day controls provide greater protection from shopper parking than a 2 hour zone. An example of all day controls is the Green Lanes A CPZ which operates Monday – Saturday 8am – 6.30pm; thereby offering priority for residents during the day.

All day plus evening controls are used in areas where residents might be in competition for parking with non-residents during the day and in the evening. All day plus evening controls operate until 10pm from Monday to Sunday in Wood Green (Inner) CPZ as the area has a large number of restaurants and bars which attracts high levels of parking throughout the week.

Although parking is prioritised for residents in all CPZs we would still provide a level of pay and display parking for visitors to the area to enable the local economy to flourish.

Types and Costs of Parking Permits

A parking permit must be displayed during the hours of operation of the CPZ.

Permits can be obtained by phone, post or in person at the Council offices. Information about parking permits is also sent to residents and businesses before CPZs are put in place.

Charges for parking permits are used to cover the costs of operating and enforcing the scheme. Any financial surplus is 'ring-fenced' for reinvestment in the public highway. Permit charges, which have not been increased since 2007, are currently under review and this may result in changes to permit prices. Full details of current charges are set out on the website www.haringey.gov.uk under environment and transport > parking > parking permits > residents and visitors permit prices.

Residents' permits entitles them to park in residents' bays and in some shared-use bays. Where Pay and Display bays are available these can be used if a ticket is purchased from the machine.

Short-stay visitor permits are for use by friends, relatives, health visitors or trades people. They allow parking in shared-use bays and in resident bays if a 2 hour visitors' permit is obtained from the person they are visiting. Permits must be clearly displayed.

Visitors' permits must be purchased in advance by residents. Weekend visitor permits (where applicable) can also be purchased in advance and are valid from midday Friday to midday Monday.

Long-stay visitor permits are available and these allow parking for two weeks. They can also be used by residents who hire a car for a short period. These also must be purchased in advance by residents.
