5.2 Crime and Disorder

The applicant will take all reasonable steps to ensure that crime and /or disorder does not occur on the premises.

5.4 Public Safety

Appropriate fire safety procedures are in place including fire extinguisher (H20 and CO2), internally illuminated fire exit signs, a smoke detector and emergency lighting.

5.5 Public Nuisance

A maximum thirty minute wind-down period is to be provided to allow customers to slowly finish their meals/drinks.

All customers are asked to respect neighbours and leave quietly. Clear and legible notices will be prominently displayed requesting customers to leave quietly

If in doubt, the licensee and staff will ask persons who appear to be under age of 18 for photographic ID such as proof of age cards, the connexions card and Citizen Card, photographic driving licence or passport, an official



EXISTING FLOOR PLAN




