- The premises will open and shut at it's permitted hours and the sale of alcohol or any other permitted licensing activity will not be carried out at any other time than it's permitted opening hours.

5.4 Public Safety

- Emergency light will be installed and fire extinguisher will be installed.
- The fire exits will be free of any impediment or obstacle at all times of the operating hours.

5.5 Public Nuisance

- No alcohol will drunk outside of the premises.
- Suitable signage will be displayed at the point of exit advising customers to leave quietly.
- Deliveries to the premises shall only be made during normal working hours.
- Bottles and similar goods shall not be handled outside the premises in the late evening, night or early morning.

5.6 Child Protection

- Licensee will not sell alcohol to children and any persons under age.
- Where a person appears to be under the age 21, identification in the form of passport, photo driving licence or a proof of age card bearing the pass hologram will be sought and if not provided service of alcohol will be refused.
- Suitable signage will be displayed at the point of entry and at the service area advising customers that the premises operates the "Challenge 21" proof of age scheme.

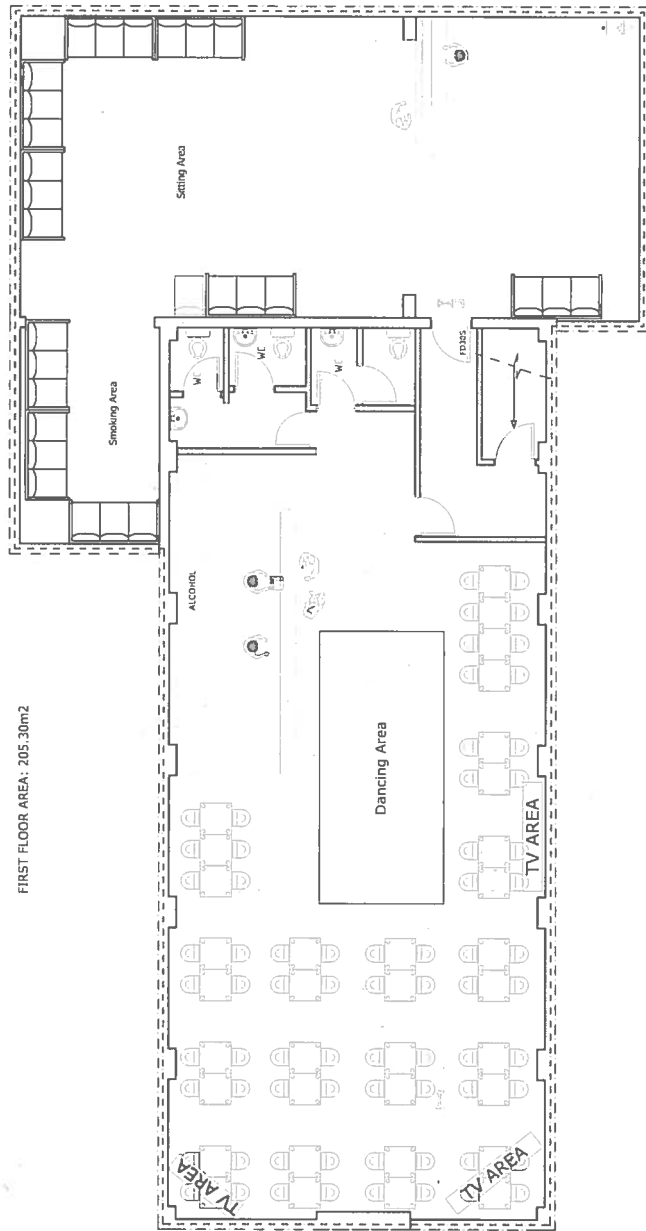

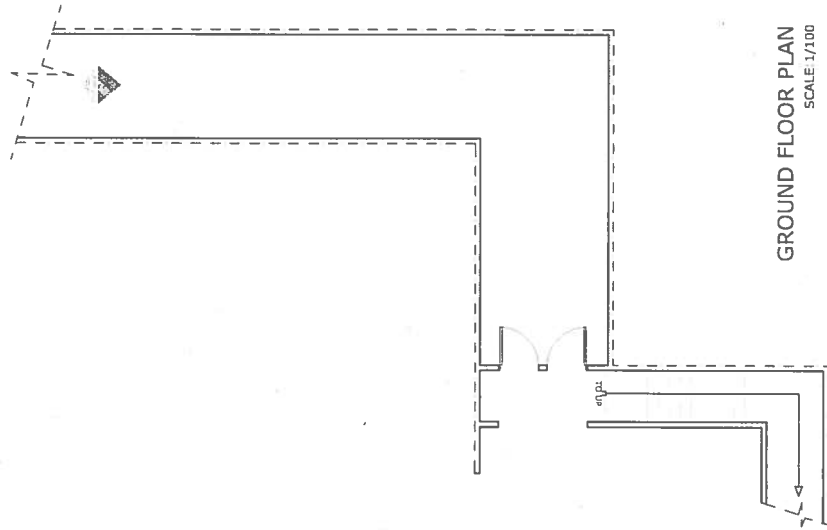

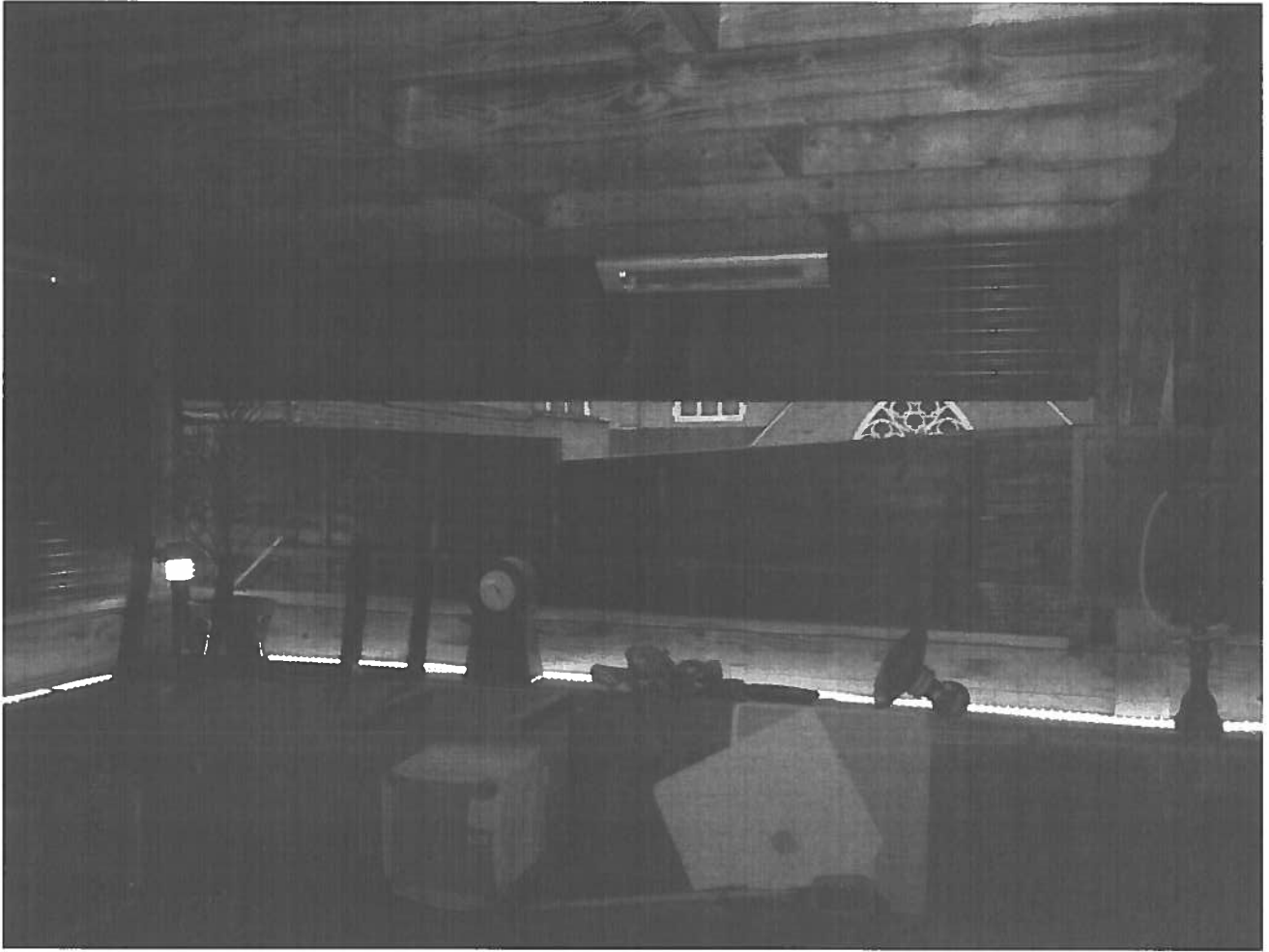

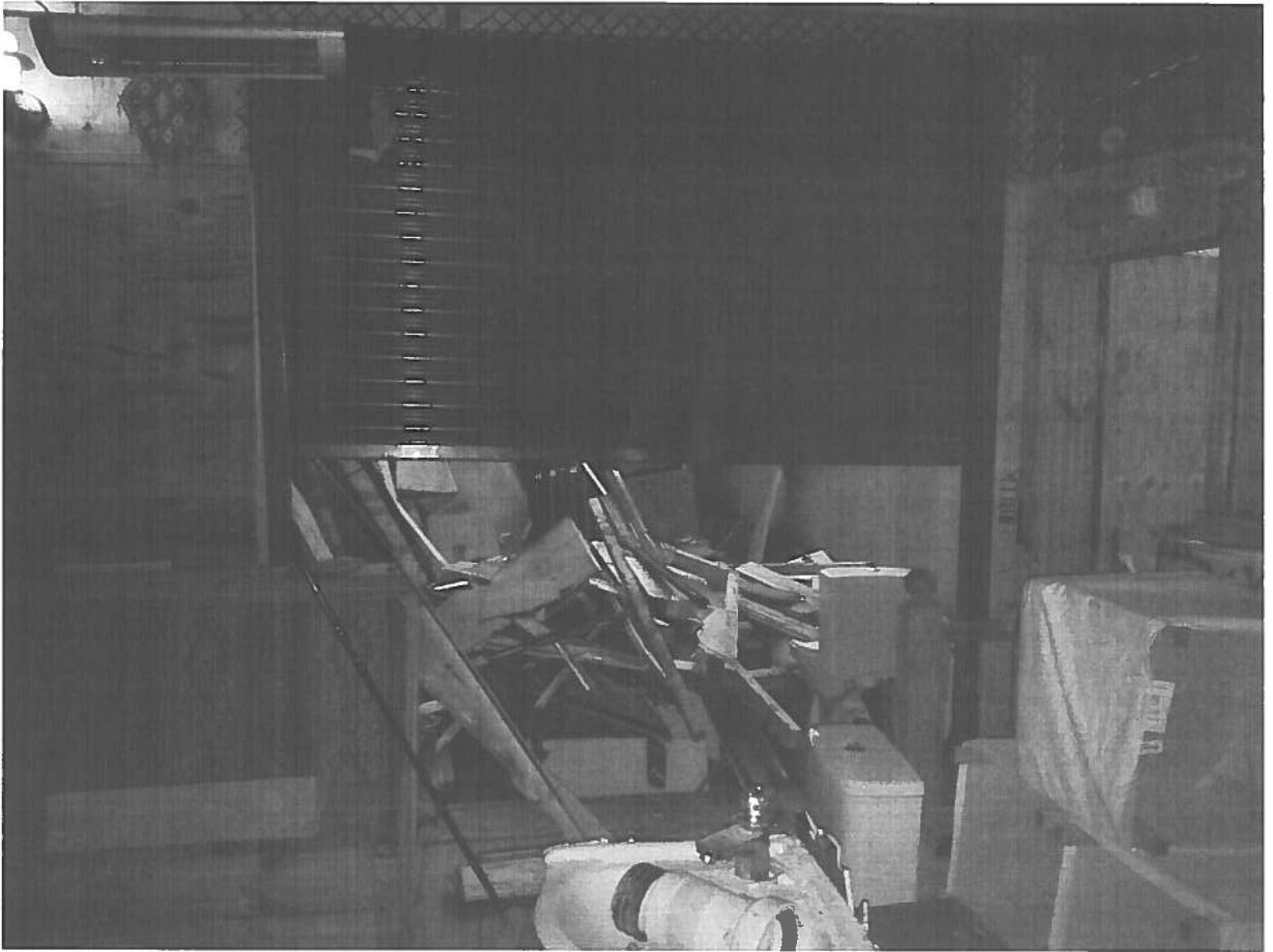

This representation recommends that the following alterations/conditions to the operating schedule:

Prevention of nuisance from noise / vibration

All doors and windows will remain closed during the licensed regulated entertainment activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Where necessary adequate and suitable mechanical ventilation should be provided to public areas

Entrance/exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout.

The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties

Structure borne noise

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties

Sound limits

All regulated entertainment amplified activity will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager

The level of amplified regulated entertainment shall be controlled by means of limiting device set at a level from the closest residential premises and agreed with the licensing authority. The premises licence cannot be used until the level has been set and agreed with the licensing authority.

Outside Areas

No music will be played in, or for the benefit of patrons in external areas of the premises

Signs shall be displayed in the external areas requesting patrons to recognise the residential nature of the area and conduct their behaviour accordingly. The management must reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours

The external area will be closed and patrons requested to come inside the main structure of the premises at 2300 hrs

Deliveries and collections.

Glasses will be collected from the external area at the beginning of the day rather than at closing time when neighbours in close proximity might be unduly disturbed

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise

Patrons entering/exiting premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manner

Signs should be displayed at regular intervals of approximately every 10 yards in the corridor which leads from the entrance on Green Lanes to the staircase leading into the bar requesting patrons to respect the neighbours and behave in a courteous manner

Door supervisors:

To prevent disorder and damage to be required on Friday & Saturday and also on nights when TENS apply and on Christmas Eve, Boxing Day and New Years Day when any regulated entertainment starts through to the close of premises

When the premises turn out, a licensed door supervisor shall supervise patrons and ensure they leave in a prompt and courteous manner, respecting the neighbours.

A licensed door supervisor will be positioned on the exit door to ensure, as far as reasonably practical, that patrons do not leave drinks.

A licensed door supervisor will patrol the curtilage of the premises to prevent patrons urinating in public areas in the vicinity of the premises.

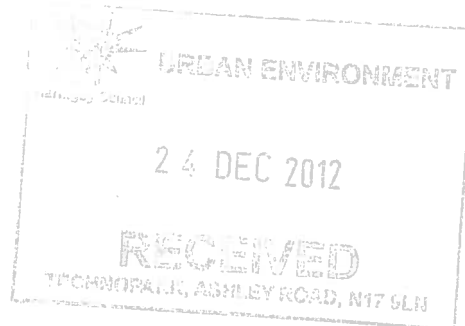
Prevention of Nuisance from Odour

New premises licence: Café Ora, 581a Green Lanes, N8 0RG

I am writing to you as a local resident who lives in close proximity to the above premises to express my objections to the proposed licensing application.

I believe that in the context of a residential area, granting a licence for the activities and hours requested would be against the general principles of Haringey's Licensing Policy and specifically under the following headings:

- The Prevention of Crime and Disorder
- Prevention of Public Nuisance

I am concerned, in particular, at the issues surrounding the prevention of public nuisance, in the light of the specific location of the proposed venue.

I note that Haringey's current Licensing Policy document specifically refers to the problems caused by noise nuisance, which is my particular concern. The following points in it seem to be very relevant:

- 'noise nuisance is of particular concern ... especially at night when the ambient noise level is low' [14.3]
- 'noise nuisance is also of particular concern ... especially when doors and windows are kept open or the use of the so called "shisha/beer garden from opening till closing
- 'the conduct of customers leaving premises or spilling out into public and open spaces is often a source of disturbance and anti-social behaviour' [14.4]

- ‘the potential for additional crime and disorder and/or public nuisance is increased with longer hours.’ [19.1]
- ‘when issuing a licence, stricter conditions with regard to noise control and/or limitations to opening hours may be imposed in the case of premises where relevant representations are made and that are situated in largely residential areas. Operating hours between 23.00 and 07.00 are considered to give greater potential for noise nuisance’ [19.3]

I am very concerned about the location of the premises and the existing history of noise nuisance. The site is not directly accessed from Green Lanes, but is at the far end of an access/service passage. There is no other entry or exit as the passage is a dead-end. The proposed venue is directly adjacent to and above many residential properties in Green Lanes and nearby homes in Allison Rd.

The passageway has obvious potential for anti-social behaviour and noisy customers gathering together on leaving and entering the venue. This will be at its worst late in the evening and the early hours of the morning. The current hours are already bad enough, but the proposal is to extend them yet further, so that the premises will remain open until 12.30am (M-Thurs), 2am (Sun) and 2.30am (Fri-Sat).

These are very late hours, and in the case of Fri & Sat, later than any other nearby venue in Green Lanes. This obviously has the ability to cause very significant late night nuisance for residents, based on my experience of noise nuisance under the existing, and more limited hours. I have had to call the Noise Nuisance Team on about 10 occasions - so many that I have lost count! However they will have all the details of the call-outs for your inspection.

I am concerned that this will only get worse with longer hours and therefore urge the Licensing Committee to reduce the hours in the current application and require strict conditions about the closing of windows and doors in order to prevent further noise nuisance from arising.
