## 6. Description

An application for conversion of the existing licences pertaining to Public entertainments and Justices liquor licences was submitted to London Borough of Haringey on 29<sup>th</sup> July 2005.

The application was extended to include details of desired variation of hours.

The variation on hours was as detailed below:

Normal Public opening hours	0600- 0300.
Sale of Alcohol	1000 - 0200.
Late night refreshment	2300 - 0200
Recorded music	0900 - 0200.
Films	0900 - 0200
Indoor sports	0600 - 0200
Boxing or Wrestling	0900 - 0200
Performances of Dance	0900 - 0200
Provision of Facilities for Making Music	0900 - 0200
Provision of Facilities for Dancing	0900 - 0200

In addition to the above hours the application also applied to extend the normal hours (as listed above) to a period of up to 24 hours for pre booked functions on notice to the council and police of at least 14 days.

The matter went before the Licensing sub committee on Tuesday 25<sup>th</sup> October. The sub committee considered public representations from concerned local residents and heard evidence from Capita Symonds on the subject of noise levels during music events.

The Statutory bodies raised no objections except for the police who requested a longer notice period of 21 days for small events and 3 months for large events.

Due to a legal issue the sub-committee chose to adjourn the meeting without decision.

The matter was further considered on 2<sup>nd</sup> November and the licence was granted subject to various conditions relating to noise prevention, notice of large events and the holding of a planning meeting with the various statutory authorities.
