Why is the Council having this Consultation?

Haringey defines consultation as 'a process of dialogue which leads to a decision'. To make sure people who live and work in the borough have a say and influence decisions that affect them, we are committed to making sure all Council consultations are effective and efficient.. The Council is also required, under regulation 18 of the *Town and Country Planning* (Local Planning) (England) Regulations 2012, to consult on documents it intends to adopt as Development Plan Documents. As part of this consultation the Council must invite representations from residents, local businesses, local and national interest groups, as well as other government bodies.

The community involvement and consultation activities undertaken in planning will reflect the Council's equal opportunities commitments and priorities, as set out in the Council's Equal Opportunities Policy 2008.

Who will be consulted?

Haringey will seek the views of those who live, work and spend their leisure time in the borough. As well as those organisations whose activities affect life in the borough such adjoining land owners, the Police, Health Services and the Mayor of London. What are the documents?

Alterations to the Local Plan: Strategic Policies

Haringey's Local Plan: Strategic Policies was adopted in 2013. Following the publication of the Further Alterations to the London Plan in early 2014, the Borough's housing allocation and target to increase employment levels has increased over the next 20 years. The Borough has also updated the local evidence base to keep abreast of emerging development patterns and other market trends. Given the change in the growth forecast, and the updated local evidence, the Council has taken the opportunity to review some of the strategic policies with a focus on factually updating policies.

<u>Development Management Development Plan Document</u>

The Development Management DPD will support the Local Plan by providing detailed policies, which will be used to assess and determine planning applications. The policies will assist in delivering the objectives of the Council's Local Plan, and the London Plan. The Development Management Policies will guide development at the planning application stage to ensure we:

- o get the right development in the right place
- o deliver the best design
- o enhance our borough's infrastructure

<u>Site Allocations Development Plan Document</u>

The Site Allocations DPD introduces the key development sites which will accommodate the majority of development in the borough over the next 20 years. In order to de-liver the improvements that Haringey residents aspire to, the Council must have the appropriate powers necessary through the statutory planning system. The Site Allocations approach will help to build consensus in the community and with our various stakeholders and is an objective approach for balancing competing priorities and promoting positive actions.

Tottenham Area Action Plan Development Plan Document

The Tottenham AAP is a comprehensive spatial strategy for coordinating development which reflects the community's aspirations for the area. An AAP has a strong focus on delivery and implementation which is in line with Government guidance for areas of significant change. This focus provides certainty and clarity to residents, businesses and potential investors in the area.
