Terms of Reference Schools Forum Funding Block Sub-Groups.

Overall Purpose of the Group:

 to advise officers on high needs issues and review funding allocations within the High Needs block to ensure that funding meets needs and supports both statutory obligations and local policy and strategy for Children with High Needs.

Membership:

The membership of the group should include representatives from all types of institutions affected by High Needs Block funding decisions. It will normally be drawn from Schools Forum members; however it will be possible to co-opt **up to a third** of the membership from outside that group if required to ensure adequate attendance or access to specialist expertise. Key officers of London Borough of Haringey will also be co-opted members.
