The Chair invites comments from the parties on the suggested topic headings and decides whether to confirm or vary them. **WITNESSES** 7. The Chair asks whether there are any requests by a party to call a witness and decides any such request. 8. Only if a witness is to be called, the Chair then asks if there is a request by an opposing party to "cross-examine" the witness. The Chair then decides any such request. **DOCUMENTARY EVIDENCE** The Chair asks whether there are any requests by any party to introduce late documentary evidence. 10. If so, the Chair will ask the other party if they object to the admission of the late documents. If the other party do object to the admission of documents which have only been produced by the first party at the hearing, then the documents shall not be admitted.
