Performance of dance and provision of facilities for dance (outdoor)

Supply of Alcohol (consumption on the premises)

Originally the application was for all licensable activities to run to 03:00 daily with a closing time of 03:30. This was subsequently amended to the hours above.

General-all four licensing objectives

5.3 Crime and Disorder

The premises licence will be clearly displayed within the venue.

LICENSING ACT 2003 Sec 24

There will be a maximum of 250 persons.

Evenings with regulated entertainment will be ticketed or alternatively a counter will be used to ensure maximum occupancy is not breached.

Notices will be placed on exits to remind patrons to use the facilities and leave the area giving respect to neighbouring buildings.

Notices will be placed in toilets notifying patrons of the venues zero tolerance drugs policy.

CCTV will cover all major areas of the premises ad will be kept for 30 days.

SIA accredited staff will be used depending on the type of entertainment being provided.

All staff will be trained in the challenge 21 scheme.

5.4 Public Safety

A log book will be kept on site to record any accidents.

All parts of the premises will be regularly checked to ensure they are in good working condition.

Drinking water will be made available for free.

There will always be at least 1 qualified first aider on site.

A fully equipped first aid box will be kept on site.

5.5 Public Nuisance

Patrons will be asked not to stand in the street after exiting the venue.

A notice reminding patrons to leave quietly will be in place.

Bins will be placed on the exit and customers will be reminded to place their refuse in the bins provided.

5.6 Child Protection

When showing films the film classification will dictate the patrons age.

Children will be welcome depending on the entertainment on offer.

No children will be after 9pm.
