



Objections to Hatch Yard Side of Gaunson House, Markfield Road, London N15 Proposal

The group/company (Hatch) applying for the liquor licence and change of use planning consent organised a meeting for local businesses to tell them of their plans and discuss any issues. No local businesses would have attended because none of them were informed of it. 2 local businesses and one interested party attended as well as a council official. I by chance found out about it and attended the owners of the location where the meeting took place, a Café in Gaunson House and one other.

I hardly call that a represented cross section of businesses.

When I asked the applicant why all the local businesses where not told about this meeting, he was dismissive about it and said that he did not have time. I then told him it would have taken 10 to 15 minutes knock on the affected businesses and tell them about the meeting.

The applicant should have at least spent a £1 or £2 to photocopying a leaflet outlining the proposal and telling local businesses or at least putting it through there letterbox to attend, giving at least 1 or 2 weeks' notice.

Most businesses on Markfield Road and Constable Crescent are not aware of this proposed open air venue or do not realise its implications to their businesses.

Their Proposal

An Open air venue for the following use:

Outdoor cinema/big event screenings (e.g. Football matches), table seating for supper clubs/ food events, a yoga space, workshop space, small market arena, or a dance and performance area.

The venue would also be available for daily hire e.g. wedding, receptions, birthday parties etc.

Cook Food and Sell Alcohol.

Points as they affect us:

Music / Noise:

Our Business operates from around 8:30 am to 7:00pm Monday to Friday

We can clearly hear any and all conversations that currently talks place in the yard particularly when closer to our building or if loud from the other end and our conversations can be heard by them. They are proposing to playing Music from what I recall 8:00am to 1:00am to 3:00am the next day. Then you have to add the noise of the customers and potentially that could be a few hundreds when on private hire, should make their proposal untenable on just the notice **noise nulsance** element.

Smells:

They are proposing to situate toilets against our building. From the proposal there will be 2 toilets and the fire department will allow around 300 people. 2 Toilets are not sufficient for that number of people and if a blockage occurred the smell will cause a big problem for us. We also have air vents on our buildings back wall so the smell of the toilets and the cooking will come through 24/7 which is totally unacceptable.



Dust:

This area is very dusty particularly on a dry day needing only a light wind. My back wall that separates my drive and the proposed site is high so will reduce the dust to some degree but will not stop it. They will have to correctly install fine netting over the whole site to reduce the dust. Otherwise the meals and glass filled drinks there customers purchase will be getting a light dusting of sand and all kinds of particulates. I see a health issue here!!!!

If I were to park a freshly washed car on my drive which is right in front of the proposed venue/site, on most dry days with a light wind or stronger, by the end of the day you will find a film of dust which on many days will be quite thick. You would be able to see that cars parked around my building are covered with sand

Parking:

There is an acute shortage of parking on Markfield Road and the situation will be made worse by this proposed venue. They indicated that they would encourage people to park at the Tottenham Hale Retail Park. Once someone has parked on Markfield Road or Constable Crescent they are not going to move. This makes it difficult or impossible for our customers and or suppliers to park hampering our business. Why should the retail park which is privately owned be burdened with people parking there but not shopping there. At certain peak times parking can be difficult at the retail park, so why should those businesses suffer. If customers cannot find parking they just go else ware and not necessarily to other local businesses. With large trucks constantly using Markfield Road, and especially when there is a big event, a large influx of cars, most trying to find parking and more people crossing the road, more cyclists etc. would potentially lead to more accidents. A safety issuel!!!!

Safety Hazards:

- 1. Gas cylinders for cooking plus spare cylinders,
- 2. Bomb shelter roof as an obstruction in case if fire or a brawl etc.
- 3, Narrow entrance walkway which will have a rows of dustbins lining it. That can cause a major obstruction in a stampede that could potentially lead to injury or possibly death.
- 4. No quick and easy way the Fire Brigade an access the venue. This was shown to be the case when the fire brigade was called I believe last year or possible the year before and they just did not know how to get to the site. (A small rubbish fire was getting out of hand)
- 5. The proposed emergency exit near the cooking area in the wall opposite our building that leads to a small private road/drive is not a reliable fire exit. Over the years I have personally seen on many occasions a large truck parked on that narrow road for days on end. If that here to happen they would lose that emergency exit. Again this is a private road/drive so they would need to legally secure 24/7 blockage free access with barriers so no one can block that road / drive.
- 6. The proposed venue in effect (at least in the evening) will be an open air night club. There will without doubt be drunks walking on the road, urinating, vomiting, food and other mess thrown on the streets. How are "Hatch" going to handle that? As usual the council will eventually clean the mess but we the businesses have to suffer this. We have customers coming from around the world to do business with us and it is embarrassing enough for them to see unrepaired potholes and the very poorly maintained roads but added to that rubbish every were. Various Health and Safety issues!!!!!



Violence, theft and Vandalism:

With a large gathering for private hire or footfall match screening etc. there is always a danger of violence. As mentioned above the site is not suitable regardless of how many bouncers and security personal you have. Even if nothing happened at the site the trouble could spill out onto to the streets causing damage to cars and property.

Previously No: 62 was used as a church and hire Venue and when hired there was a shooting incident that stopped businesses entering the premises in the morning, regular unsocial and threating behaviour, rubbish thrown on the streets etc. **Public Safety!!!!**

I can go on but I think I have covered most important issues here.


In our board meeting the one thing Haringey Council always championed was that the council want to help businesses especially those that enhances Haringey.

I am forwarding my objection to the above application on the following grounds. I have been trying to locate the actual notification of the license but have been unable to see it anywhere on the outside of the premises.

1. The prevention of crime and disorder;

The hours stated 09.00am to 03.00 am would create a massive influx of people and interrupt the normal running of what is already a densly used commercial and residential areas both local residents and businesses will be adversely affected with an increase in petty crime like vehicle damage, abuse incidents littering and anti-social behaviour and noise nuisance caused by the sale of alcohol for this length of time and the numbers of people using the premises. The playing of loud music in both the day and night time will also effect the use of our property and other local residents properties as in the summer especially we will beunable to open windows when the loud music from live bands and Dj's is playing .

2. Public safety:

I consider the location of this proposed license to be extremely dangerous firstly it is waste land were a fire had already occurred and the firemen had a serious problem to reach as there is NO ACCESS for their trucks they had to run their hoses through another property and climb a wall to reach the fire. Fire exits would be seriously impeded by the narrow exit area especially if both the entrance and exit are in one area I have been advised that the width of the exit would impede the numbers allowed in the premises and if there is only 1 exit surely if the fire is in this area there is a serious consideration to public safety and this closes down the number of people allowed to be on the land at anyone time. Also were they are considering setting up backs onto to our premises we have numerous items ie gas bottles, machinery etc that should the use of cooking / electrical items nearby catch on fire could cause a major incident if the fire then spread to our property especially with the impeded access putting our staff and lively hood also at risk. People under the influence of both alcohol and in some cases drugs are an added danger to what is already an area were a high traffic flow of commercial vehicles is we have to consider

3. The prevention of public nuisance; and

We are a commercial company using what is designated employment land with the movement of LARGE HGV vehicles as are so many companies on the Markfield estate. There is already a MAJOR problem with parking and movement within Markfield Road the influx of people that will attend this premises just to run the events as well as attend will cause further problems with parking for the residential and commercial properties. There will be an increase in public litter. Increased Noise nuisance. Our staff have the right to free movement at day and night without being accosted by people who have had alcohol served for this length of time. A similar premises on Markfield Road caused our staff to have to walk out home at nights in twos we also had one of our drivers shot at by people attending a similar event. Live music venues attract all sort of undesirables to the area after so much effort has been made to improve Tottenham I cannot see how a venue in such an unsuitable location can be to anyones benefit

4. The protection of children from harm.

This venue is near to both a number of junior schools and a secondary school. Large volumes of pupils walk past at all times both the increased number of people and the addition of both alocohol and drugs can only have a negative effect on the area and put vunerable members of society at risk of abuse . This is

also next to a park and especially in the spring summer months this is widely used by families and children loud music and increased number of people can only be detrimental to the usuage of this local community by this facility.

I hope my objections are taken on board they are not just personal opionion they are based on previous incidents that have taken place from similar establishments. We have been established in Markfield Road for 26 years and are encouraged with regards to the positive efforts that Haringey are trying to make to rejuvenate the area, This is a ridiculous use of employment land.

The area outside Gaunson House is not designed for social, civilised drinking. It is a bare, dimly lit area of car park. I anticipate broken bottles or worse, abandoned glasses and the kind

of carelessness that goes with drinking in an improvised outdoor space.
