5. REPORT

Background

- 5.1 An application for a new premises licence has been made by Bill's Restaurants Ltd, in respect of 107-109 Muswell Hill Road N10 3HS. Appendix 1
- 5.2 Details of the application being sought under the Premises Licence Application

Late Night Refreshment Monday to Sunday

23:00 to 00:00

Supply of Alcohol (consumption off and on the premises)

Monday to Sunday

10:00 to 00:00

The premises to be open to the public

Monday to Sunday

08:00 to 00:30

All activities to be permitted through the night until the start of licensable activities on New Years Day

The application originally included recorded music as a licensable activity, this part of the application was withdrawn on the 7th May.

General-all four licensing objectives

5.3 Crime and Disorder

The premises shall install and maintain a comprehensive CCTV system. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon request of the Police or authorised officer.

Substantial food shall be available at all times during the permitted hours

Service of alcohol shall be by waiter/waitress service only with the exception of people waiting for a table.

Alcohol shall not be sold or supplied, otherwise than for consumption by persons who are seated in the premises and taking a substantial table meal, and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.

5.4 Public Safety

All exit doors will be regularly checked and all fire doors maintained unobstructed and effectively self closing. All fire fighting equipment wil be regularly checked to ensure they function correctly.

5.5 Public Nuisance

All staff will be trained to ask customers to leave quietly in the evening when necessary.

There will be appropriate signage at the premises requesting customers top leave quietly.

5.6 Child Protection

A challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS hologram.
