4.1.1. Design and Construction

Design Development

The current position for design development in each school is shown below.

PROJECT STATUS SUMMARY:

School:	Project Status:
STM	The amended Stage B report has been agreed by the School and Diocese and has been circulated to the DSRG, Governors and Programme Board for approval. The project will now move into Stage C this week.
GLM	The Stage D report has been issued to the DSRG for approval. A response it due back by 4 April 2008. The current design does not include for the "lobby area" that PfS would like included in between the Maths and Science and Auditorium. A scheme for this is now being looked into by the Architect. The Stage D report shows an overspend of £262K which is the re-positioned design fees.
GLM (BLF)	A letter of intent was issued to Thomas Sinden on Monday 31 st March by Haringey Legal. This is to enable and sanction Thomas Sinden to progress with achieving the build-over agreement with Thames Water and to enable them to mobilise resources to complete site set up during Easter Holiday's. PRP / Thomas Sinden are working towards providing Haringey Legal with contract documents as soon as possible to finalise the contract.
WSH	The project is currently on budget, and 16 weeks (at practical completion) behind baseline programme. The planning application has been submitted. The preparation of Employer's Requirements has begun. A decision on whether sprinklers are to be installed is required.
PVA	The project is progressing through Stage D after approval from the Board for Stage C. Geometry freeze has now been achieved and the room data sheets are being developed. The mini competition went out to tender this week and responses are due back 22 nd April 2008. Geotechnical and services surveys are also being carried out in the next month for additional information for the DTP.
NPS	The project in general terms is progressing well, however the increased programme will cause the school serious problems as piling works were planned to take place during the summer holidays such that new build work could commence in September 2008.
JLS	The project is progressing reasonably well with the new staff at the school having a very positive effect on all aspects of the scheme. Stage D work is nearing completion and a planning application has been made, slightly ahead of programme. There are no significant problems causing the team concern other than the known delays.
NEW	The project remains in a critical condition; it remains significantly over the funding allocation and due to delays in Stage C revising the design and incorporating sustainability elements, compounded with the revised procurement route the occupation by school is now programmed at 6 weeks later than the September 2010 opening date. Elements where the programme might be recovered is through the processes and approval pre-construction or during the construction stage which will not be explored until discussions with Contractors commence post Stage C.
PSC	The DCSF have accepted the authority's proposals but will not be providing any additional funding to meet these aspirations. Therefore the cash limit budget will need to be reduced unless funding is provided from elsewhere. Options are currently being considered with an intention to agree a position by end early May.
HGW	The scheme is currently in Stage D and had its early Stage D review with PfS last week. PfS agreed with the proposals for the teaching block, however, comments were made around the current inadequacies in dining and circulation. It was stated that if these were not addressed Stage D would not be signed of by PfS. If this were to be included within the project it would be at an extra £1.16m

School:	Project Status:
HOR	The School Governor's have agreed (Committee Meeting on 6 th March) to the New Build being located on the grassed area at the front on Inderwick Road (rather than on the existing car park). Final scope of works for Stage C being pulled together for Stage C / Elemental Cost Plan.
FOR	Continued dialogue has taken place with the school around affordability and options. After consideration of the options the school has agreed that music takes priority at this stage and a scheme has now been agreed in outline. This will enable the project to move forward to the stage B report.
ALP	The Core Support Team have established a solution to achieve the majority of key priorities set out in the ISV within the Cash Limit Budget, this will need to be reviewed in detail by the DSRG & PfS to sign off the FBC. The Stage B report will be presented to School Governors for approval around the week commencing 21 st April. The status moves to amber as the programme is adrift, due to delays in Stage B in achieving an affordable solution and the revised procurement process being introduced.



Other Programme Activities



Strategy for Change

- SFC2 has now been approved by PfS. This approval from PfS was subject to a small number of conditions. These focussed on the need for the LA to ensure schools' SFCs align with the LA's SFC and to continue undertaking work on extended schools.
- SFC2 has now been sent to the Department for Children, Schools and Families (DCSF) for approval.

E-transformation

 The e-transformation document, titled 'Towards an e-transformation' is now with members of the ICT forum for consultation. Comments will be captured in the form of an online survey. This will serve as an initial working strategy until further consultation with the preferred Managed Service Provider. The deadline for comments to return is...

Extended Schools

- The initial drafts of both extended schools strategies have been completed by Continyou.
 Initial consultation has already begun, with amendments being made to the overarching strategy by Jan Doust and Sam Davidson. The extended schools strategies are tabled at the STB.
- The full bursars group were consulted over the management of lets. The full bursars group agreed that the proposals for a website and advert in Haringey People should be postponed until further notice. The transformation stream are to hold a meeting with the full bursars which will focus solely on extended schools
- Sam Davidson and Lucy Callan have begun the asset capture exercise for extended schools
 facilities across the borough. The results from the first visit to Woodside High have yet to be
 received. Upon receipt of these a further two schools will be visited and their results analysed,
 prior to the exercise being offered across the borough.

Provision for Young People with Mental Health Needs strategy

Dialogue with DCSF has resulted in agreement with the general principles of what we are
trying to do in Haringey. Funding, that had already been committed, remains in place to
enable each secondary school to build provision for a student support centre. Amendments in
budget for the Young People's Centre (formerly PSC) may impact on what can be built, but
the BSF team have worked with PfS to try and minimise this. Options for the YPC are still
being considered.

ASD strategy

• The draft ASD Strategy has been finalised. This has now gone to the design team.

14-19 provision

 Good progress is being made on the 14-19 strategy. Six Diplomas will be in place by September 2009. School ISVs and building designs reflect the 14-19 requirements.

Training Schools

The STB will be updated on progress by the training schools in summer 2008.

BSF Programme Appointments

 Aaron Bigmore PM will be joining the construction project management team. Aaron will be shadowing the project managers at Alexandra Park School and Northumberland Park.

Communication

- The BSF ICT student survey has now closed. More than 2,700 responses were received, the results are now being analysed.
- New School Roadshow has seen 19 visits to primary schools to meet and discuss proposals for the school with parents, and several resident / community events have also been held – feedback from this consultation is being compiled
- Individual Communications Plan are being developed and implemented for each school
- · Briefings for members are ongoing.
- A number of drop-ins/ consultation events at BSF schools have been earmarked.
- Latest BSF newsletters for schools including JLS, PSC, NPS drafted and shortly to be distributed to schools and local community.

1. Key Activities in this reporting period (15th March-15th April):

Procurement of Managed Service Provider

- ICT stream met with the Secondary Heads to answer outstanding questions and present the second round of FAQs, had agreement from the heads that dialogue with suppliers could close subject to PfS signoff.
- BSF Board approved the ICT close of dialogue paper. Case conference with PfS was held on 9th April, majority of outstanding issues were resolved, waiting response from bidders (update at 14th April).
- Draft ITSFB has been issued, prior to formal close of dialogue (expected 16th April)
- Reference site visits members of the ICT Core Group visited St Martin's in the Fields school, Lambeth on 1st April to assess one of the bidders for the ICT MSP contract. The Core Group had the opportunity to evaluate the range of ICT services being delivered, speak to teachers and students about the service being received and view how ICT has transformed education. A visit to a reference site for the second bidder by the ICT Core Group is planned for 29th April in Ramsgate, Kent.
- Governing Body Agreement distributed to all heads for review and comment
