**1. Describe the issue under consideration**

1.1 The health and care landscape is undergoing significant change in order to drive a more integrated approach and to maximise use of resources for local health and care benefit. Needs analysis shows that different approaches are needed to improve outcomes and to ensure that people are supported to live as independently as possible in the community and to achieve their potential. This report introduces two areas where transformational approaches are being used to address need, manage demand and achieve outcomes, within reducing resources.

**2. Recommendations**

2.1 Members of the Adults and Health Scrutiny Panel are asked to consider and comment on the transformation processes underway in two areas:

- a) Transforming care for children, young people and adults with a learning disability and/or autism, with behaviour that challenges, including those with a mental health condition through the Transforming Care Programme.
- b) Transforming our day opportunities offer for people with learning disabilities or living with dementia.

Presentations on how local health and care services are being transformed in these areas will be made to the meeting for discussion and comment.

3.1 These two areas have been selected for focus at the Adults and Health Scrutiny Panel in recognition of the impact the approaches will have on how people are supported to live more independently in the community, with appropriate support.

## **5. Background information**

5.1 The Transforming Care Programme is a national initiative which focuses on children, young people and adults with a learning disability and or autism, with behaviour that challenges, including those with a mental health condition. We are joining up with partners across North Central London to ensure the programme is delivered effectively for Haringey. The programme has a number of objectives including to:

5.1.1 Reduce the number of people with learning disabilities and/or autism in hospitals by half by March 2019

5.1.2 Reduce average length of stay

5.1.3 Eliminate use of out of area placements

5.1.4 Eliminate existing health inequalities

5.1.5 Transform care and support to be designed around the individual

5.1.6 Improve the quality of life for people with learning disabilities and/or autism and reduce behaviour that challenges

5.2 Transforming our approach to day opportunities represents a move away from day services delivered through building based provision to day opportunities which are more personalised to individual needs and preferences. Within the model, service users will be able to access both a range of community based opportunities and to access provision in the appropriate Community Hub – whether at the Haynes (for people living with dementia) or at Ermine Road (for people with learning disabilities and or autism).
