#### 2 Recommendations

There is no recommendation, but in considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:

- Grant the variation as requested
- Grant the variation whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application
- 2.1 Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely becaus it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.
- 3. Background
- 3.1 The premises has operated as a social club since October 2008. Mr Ifyeangi took over the premises in May 2013 and there have been complaints about the conduct of customers and noise disturbance emanating from the premises. This lead to a review of the licence in early 2016 on the grounds of the prevention of public nuisance not being upheld and promoted at the premises.
- 3.2 The LSC has a new application to consider and if the committee see fit to grant a new licence to allow for later hours at the venue the current licence would be surrended by the licence holder.
- 3.3 During the consultation period letters of representation were received from a residents concerned that the hours being sought would meanthe premses would operate as a night club style operation and thereby lead to noise nuisance and potential anti social behaviour in the area.
- 3.4 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.
- 3.5 The Licensing Authority considers that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to be adversely impacted.
- 4. Policy Implications
- 4.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.



#### 4.2 Eqalities impact

At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub-Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.




# **Proposed conditions for Chidos Lounge**

- 1. The Premise Licence Holder shall ensure that the premises shall install and maintain a comprehensive CCTV system;
- All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. Includes coverage of all internal areas to which the public have access (except individual toilet cubicles), and external areas.
- All recordings shall be stored for a minimum period of 31 days with date and time stamping.
- Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31-day period.
- The CCTV system should be updated and maintained according to police recommendations.
- A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage when requested.
- 2. The Premise Licence Holder shall ensure that an incident log shall be kept at the premises, and made available immediately upon request by an authorised officer of the Council or the Police, which will record the following:
- All crimes reported to the venue
- all ejections of patrons
- any complaints received from neighbours
- any incidents of disorder
- all seizures of drugs or offensive weapons
- any faults in the CCTV system
- any visit by a relevant authority or emergency service

The information should include, where disclosed, the complainants name, location, date time and subsequent remedial action undertaken.

- 3. The Premise Licence Holder shall ensure that telephone calls for taxis may be made for customers without charge on request.
- 4 The Premise Licence Holder and/or Designated Premises Supervisor shall encourage patrons awaiting collection to wait inside the premises.

- 5. The Premise Licence Holder shall ensure that prominent, clear and legible notices shall be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and area quietly.
- 6. The Premise Licence Holder shall ensure that noise or vibration shall not emanate from the premises which could cause a nuisance to nearby properties. Except for ingress and egress through the entrance, doors and windows shall be kept closed (but not locked) whilst regulated entertainment is taking place.
- 7. The "challenge 25" scheme shall be operated and relevant material shall be displayed at the premises. Only passport, photographic driving licences or ID with the P.A.S.S. logo (Proof of Age Standards Scheme) may be accepted.
- 8. The Premise Licence Holder shall ensure that all relevant staff shall receive induction and refresher training relating to the sale of alcohol and the times and conditions of the premises licence. The training shall be recorded, ongoing and under constant review and made available to a relevant Responsible Authority upon reasonable request. Refresher training shall be undertaken by the relevant staff at least every 12 months and documented as above.
- 9. The Premise Licence Holder and/or DPS shall ensure that a written record of all refused sales are kept on the premises. This record shall be made available to Police and/or local Authority upon request and shall be kept for at least one year from the date of the last entry.
- 13. The Premise Licence Holder shall ensure that children under the age of 18 shall not be admitted to the premises after 21:00 unless they are accompanied by an adult.
- 14. The premises licence holder shall ensure that where regulated entertainment takes place on a Friday or Saturday, SIA registered door staff will be employed at the premises from 9pm until the cessation of those licensable events.

#### The Prevention of Crime and Disorder

As a resident of grove park Road for over 20 years I have noticed that there seem to have been an increasing number of people hanging around the premises, though not entering it. These individuals are often drinking from cans of lager/beer in West Green Road most evenings and I feel that granting a license to the nightclub will only exacerbate the number of people drinking in the vicinity, which is already a designated drinking control area, it will encourage revelers to continue drinking in West Green Road and continue to cause a nuisance to other road users and local residents.

I have personally witnesses a number of people exiting the premises and using the wall around the corner as a public toilet which I find frightening and extremely disturbing and frightening. The police already have had a number of calls when the premises was a snooker hall due to antisocial behavior and I feel this antisocial behavior will continue if a license is granted to the Chidos Lounge.

#### **Public Safety**

As highlighted above there seems to be an increasing number of people drinking in the street at various points throughout the day. I feel that the presence of a night club will only encourage these people to continue drinking regardless of the time of day and will continue to cause a nuisance to those trying to shop or walk down West Green Road. I also feel if a license is granted it will increase the traffic in an aiready busy road.

#### The Prevention of Public Nuisance

I feel that is a license is granted this will create a lot of additional noise in the surrounding area and will disturb what is a residential area. I also feel that this will encourage an increase in the number of street drinkers in the area who already make a nuisance of themselves.

### The Protection of Children from Harm

As with licensed premises some of the revelers will not necessarily leave the area after the premises has closed and I don't feel that children should have to witness, people drinking outside the nightclub whilst in West Green Road or even worse witness public urination or other antisocial behavior.

Dear Licensing Team,

I am writing to voice my very strong objection to the granting of a full alcohol and entertainments licence to Chidos Lounge, 98 West Green Road, Tottenham, London N15 5NS.

This property is on the corner of the street that I live on. Every time I walk past this building on the way home, I have to run the gauntlet of groups of men selling drugs, drinking, urinating, parking mopeds and scooters and bikes on the pavement. I have to walk in the road, as they often block the pavement. This starts around 16:30 - 17:00 and continues late into the night. Beer cans and bottles litter the street in the morning. The door to a utilities box is frequently ripped off. The idea that it is appropriate to worsen this situation is appalling. The current property does not, as I understand it, have an alcohol licence and the situation is this bad: it will be completely intolerable if alcohol is made even more easily available and noise will be added to the problem as well.

West Green Road has started to improve recently, with some shop renovated and the 'pocket park'. However, it can still be intimidating to walk along the street from the tube station - leering, muttered suggestive remarks, altercations between groups of men all detract from this though, so there is still some way to go. This kind of behaviour will be made worse if the streets are full of drunks pouring out of a club, fuelled by alcohol. The last thing we need is to increase the opportunities for crime, public nuisance and disorder.

People live in this area. The noise levels would be increased to an intolerable level, not just by the club itself, but also by the people hanging around as a result of its opening. On my street, maybe 2-3 houses up from the corner, a new family has recently moved in, with young children: they won't get much sleep if this licence is approved, and they will be subjected to the litter on the streets in the mornings on the way to school. My immediate neighbours are elderly and rarely leave the house after dark: introducing more facilities that risk isolating them, other young families and older people even more should not be considered.

The potential for a club to increase traffic is a further public safety issue. Traffic on West Green Road is already appalling, with people seemingly able to use their mobiles, drive too fast and ignore the pedestrian crossings without penalty. This will be worsened by a club, bringing more vehicles into the area. I don't remember the last time I saw any police dealing with the gangs of men on the corner or the traffic problems.

West Green Road was rated the 5th most unhealthy high street in London, by the <u>Royal Society for Public Health</u>. I would have thought that Haringey's ambition would be to take it up the rankings, aiming for a healthier high street for its residents. Granting a licence to this club would suggest that the Council is, instead, aiming to be first, and win the award of the first most unhealthy high street in London.

I'm am writing to express concern regarding the licence application for the Chidos Lounge and urge you to reject this application.

The premises is on the corner of residential street, where I am a resident. The grounds for my objection to this application are:

- the application would significantly extend the time period for disturbance on a residential street. A 2am closing time would generate noise both from people exiting the premises, congregating at the exit, and parking.
- there will be an increase in the level of noise from the venue itself if music and/or performances are allowed.
- the license would increase the volume of people congregating at the street corner. Groups of men already gather outside of the premises, an increase in numbers using the premises would increase this problem. Already it is often necessary to walk into the road as the pavement is blocked with men congregated on Grove Park Road.
- the men congragated outside the venue are a source of anti-social behaviour street drinking, urinating in public, sitting on the walls of the houses and drug dealing. An increase in the numbers using the venue would further increase this anti-social behaviour in an area which the police identify as a 'high' crime area.
- Previous representation has been made to the licence applicant regarding the behaviour of their customers outside of the premises, but this has not led to any change whatsoever. The licence applicant has also had repeated breaches of their existing licence both with regard to the noise nuisance and operation outside of licence hours. These breaches have happened over the course of several years. They have therefore not demonstrated they are a fit licence holder or will take any steps to address the potential increases in public nuisance.

My home is in However I have a daughter who lives with her partner in Grove Park Road, not many doors down from the Chidos Lounge, which is at the corner of her road and West Green Road. They have just had their first child a few days ago.....

The last time I visited their flat, I was dismayed at the situation that I found on that same corner, so close to where my daughter lives. Each time that my wife and I reached that corner, from late afternoon through any part of the evening, we found the pavement barred by large groups of men who stood their ground, ignored us and forced us to move from the pavement into the road in order to circumvent them. These men were all smoking, some were drinking and all were obviously taking the air outside the Chidos Lounge.

I am now incredulous to learn that these same premises are making the application to which I refer above. If anything, the place should have any licence revoked, not extended. Chidos Lounge, West GReen Road, extension of hours for alcohol sales

To the licensing officer,

We have lived at since September 1999 and have seen the impact of this club on our community, during these years and as far as we know, in the hands of two different owners.

It has been the scene of violent crime and while some of the clientele may conduct themselves properly, the club also attracts a significant criminal element. If this were contained within the premises, the impact on residents would not be quite as marked but in summer, there can be 40-50 men congregating on the pavement in our street. Some visit the barbershop across the road but never seem to cause trouble. The street presence continues throughout the seasons and only subsides in the most extreme cold and wet weather.

We cannot remember every having been consulted about this premises acquiring a licence to serve alcohol. Under the previous proprietor, an application to vary the licence was submitted, which residents opposed. This was upheld by the planning inspectorate when the proprietor appealed against the decision of the licensing authority. I am unclear as to when a licence was granted but the sale of alcohol was marked by an increase in people visiting the premises and the number of cars parking in our street. The drugs trade has moved from being obvious but not blatant. It is now conducted loudly, arrogantly, with no concern about residents hearing details of how much, how good and of what quality. The police crime map gives a picture of what we live next to. Tonight a man was shouting on his phone to a supplier, in loud complaint of about the poor quality of the drugs he was expecting to sell - customer services in Grove Park Road.

I oppose the extension of licensing hours at Chidos Lounge on a number of grounds, which are set out below.

The prevention of crime and disorder

I live in Grove Park Road, where people smoking outside the club gather in groups, where individuals drink, smoke and openly deal drugs with apparent

impunity. The police tell residents to gather evidence, then they'll do something about it. We rarely see police in our poorly lit, residential street. In the past, community support officers visited regularly and their presence reassured residents and disrupted the drug dealers' trade, but they are no longer here.

I get home from work late and walk through crowds of men gathered outside the club - I frequently see men urinating against cars and vans, making lewd remarks to young women. Tonight, I had to step out into the road to avoid a man on the pavement, casually urinating against a tree. A very elderly but independent neighbour was bemused by this behaviour, so near the entrance to her home.

Each morning, there is rubbish strewn around the pavement - only a little of this strays into West Green Road, the focus of it is in Grove Park Road, frequently with broken glass bottles. I photographed it this morning, a light day for rubbish, and will try to send the photo with this submission or soon after.

Prevention of public nuisance

Increasingly, we are being woken at night by intoxicated people shouting in the street. As I travel to work in Croydon every day - and I'm nearly 60 - this disruption plays havoc with my sleep patterns and makes a stressful job increasingly difficult. It's more than just a nuisance for our neighbours and ourselves. Not all of the club's customers are local, which is indicated by the number of large, expensive cars which park in our street, a lot of activity takes place round the cars, with people sitting in them, playing loud music, trying to engage passing women and doing drug deals.

Public safety

The area immediately around the premises in West Green Road and Grove Park Road is designated by the council as an alcohol control zone. Yet it is full of intoxicated people drinking and smoking outside the club - how can the control zone - unenforced - be made any safer by this premises extending the hours at which it is open to serve alcohol? Broken glass is a common feature of the pavement in the mornings. Cars parked at the bottom of our street, which is a 20mph zone, race up and down Grove Park Road, which has an island as a turning point mid-way up the street. Even though we have road humps, the speed achieved by cars and motorbikes is

dangerous to people and animals - a cat died as a result of head injuries sustained recently, late at night. The same applies to the 20mph zone in West Green Road, which we refer to as the race track.

Women are intimidated by the treatment visited upon them by the men who frequent this club. Leering, accompanied by sexist comments, is commonplace. In summer I have seen men follow young women up the street, pressing their unwanted advances. On it goes.

### Protection of children from harm

The level of drug dealing at 98 West Green Road presents a menace to teenagers in this part of Tottenham, where the number of young people with severe mental health issues requires specialist services to support them. We are seeing teenage neighbours beginning to frequent the club and to associate with its customers hanging about in the street - it's a well known spot to score dope in our neighbourhood, unfortunately, a service which is enthusiastically taken up by some local kids. A neighbour whose son has severe mental health problems despaired at the ease with which he could buy skunk outside the club, a situation which has had the most appalling consequences for this young man and his family.

Given our concerns about the nature of some of the clientele of this premises, in relation to personal safety, I would be grateful if my personal details were not revealed with this submission.



The above premises is at the corner of my road, and we need to walk past it to get to the shops and the tube. This premises already causes a severe public nuisance and encouragement to illegal drug dealing, and I fear that granting such a licence will only make matters even worse.

Having such a night club operating until late and selling alcohol is totally inappropriate in a residential area. It will lead to an increase in anti social behaviour such as noise late at night, and drinkers urinating and vomiting

There are already very often groups of men hanging around on the pavement outside this club, They sell drugs, and can often be intimidating to passers by, especially women, who are leered at and propositioned. I write to you in response to the proposal for an application for a late license at Chidos Lounge, West Green Road.

I am a resident of Grove Park road since buying a property here 18 months ago. Like many, we value the perfect location close to shops and transport links.

I had hoped, and have seen more frequent signs of, the area improving since its troubles back in 2011. Everything I read details how the Seven Sisters regeneration program is scheduled and demonstrates a real hope for Haringey council that the area will improve as the potential is clearly present.

The proposal to license a late bar and club, 7 doors away from me is completely contradictory to this regeneration. The letter highlights all of the worries a neighbour might dread so I won't go into that.

However, I have just become a father for the first time, and wish to bring my daughter up in a safe, peaceful and prosperous area. The groups of men that hang around the corner where this club might end up, already pose a threatening prospect for my fiancée to walk past every night. With a later license, comes more drunk and disorderly people. As a young female, she already deflects flippant comments, but actually, verbal abuse, from patrons of the venue and I just cannot see myself living on this road if this license is passed.

I expect this application has provoked a lot of opposition as it does not support the trajectory of improvement this area so desperately needs.

I feel so strongly about this. The bar already serves a purpose for its clients. If anything, we should be united in closing the Chidos Lounge as it is, let alone opening the flood gates to more degenerates dealing coke and weed on the street corner.

The police don't seem to care, but I really hope you do.

### - large groups of intoxicated patrons and road traffic safety

The gathering of groups (patrons or otherwise) outside Chidos and the property opposite on Grove Park Road make for an intimidating entrance to a residential road. I believe that with a later license, these groups would congregate outside the premises even longer and gravitate towards it once other premises close. There are also often many cars (seemingly of patrons or their friends) parking along or driving up and down the road, causing blocks at the junction with West Green Road. I have experienced many occasions in the last 18 months where there has been an impasse of vehicles, making it difficult to turn off of West Green Road, for access to the north end of Grove Park Road and for pedestrians to cross the road.

### The Prevention of Public Nuisance

### - noise and litter pollution

The groups who gather outside Chidos and the property opposite on Grove Park Road can often be heard shouting late into the night as it is, let alone with a later license. If this were to continue even later, it would be a nuisance to me, especially when the premises closes and they spill out. This must be even worse for properties closer to the premises than mine. The litter to be seen around the junction after a busy night is appalling. There is already enough

litter deposited around this end of the road from the surrounding properties. Increasing the time available for patrons to purchase drinks and consume them outside the property would only make this problem worse. The debris extends to urine, vomit and food remnants, which definitely attracts flies, foxes and worse. I do not believe that the licensee currently does enough to discourage littering or reduce noise pollution.

### - litter near children playing

The excess of litter - broken bottles, vomit and cans - are not ideal when there are young families living close to the premises. Children do play along the pavement and they should not have to dodge vomit all weekend. Again, I do not believe that the licensee does enough to discourage this littering or to clear up the next morning.

I am writing in regards to the opening of 98 West Green Road which is applying for a license to open 7 days a week selling alcohol, playing/recording music and selling late night refreshment etc. I reside at \_\_\_\_\_\_\_\_ and already I am not impressed with the presence in which it currently operates as it is only a few yards from my residence which is an inconvenience and causes irritation.

Every evening a group of individuals stand outside consuming alcohol, smoking, conducting illegal activities which results in unacceptable behavior; shouting, swearing, talking loudly, walking up and down the Road without considering the people living on the road, they are clearly a nuisance. The main issue is they already disturb the residence as well urinating all over the street, fighting, smoking and selling drugs all throughout day without any consideration for residence which many are elders and families with young children whom witness this kind of behavior on a daily basis.

This has been a continued issue for a numbers of years, even though we had a petition against their behavior sometime ago but clearly nothing was done about it. The police and Haringey Council know about this but nothing seems to have happened. As the area is developing and Lawrence Road has improved the area along with the council regeneration programme, why would you want to put a night club at the bottom of our street that already causes so much stress? This is not the type of neighborhood that makes me want to reside in especially with the new proposal.

Thus, I would like to reject this Licensing of alcohol and permanently have the premises closed. We petitioned before and nothing happened this cannot go ahead as this is not good for the area with the increase of traffic and the safety of our environment.

I sincerely hope that the residence who have voiced their concerns about this building and what it stands for is taken into consideration.
