Works include removal of fixtures and fittings, design and decoration including shop front and interior signage, replacement flooring and tiling. Equipment will include commercial fridge and freezer, refrigerated counter unit, cash register, tables and chairs, cutlery, pots and pans, juicer and coffee maker.
Reasons for the decision	Officers' recommendations have been approved by the Tottenham Programme Delivery Board on 6 March 2017, following evaluation of a funding application by officers, including the OIF Advisory Group made up of officers from LBH and GLA. The recommendation is to award SCO2 Ltd a loan agreement for the value of £60,000.
