No	<b>As part of the strategy there is no significant change to the service offered to residents. The strategy is simply a change in the way that resources are deployed in an attempt to have more of an impact in specific hotspot locations.</b>

Currently, residents from BAME communities, residents from minority religious or faith groups, and children and young people, lone parents, and those with long-term health conditions or disabilities are more likely than the borough average to live in areas affected by fly tips. Therefore, it can be predicted that the strategy will have a positive impact on these groups.</b></p>
